Re: De facto administrative hearing scheduled under color of law for
May 3, 2023, in the misrepresented instrument - unconstitutional bill
of attainder / foreign bill of exchange titled case number C-08-CR-
23-000122.

I, Lamont Maurice El, being an aboriginal Moorish-American inhabitant of the land / foreign national, natural person, in full life, in propria persona (not 'pro se'), sui juris, making special appearance as authorized representative, ex rel. LAMONT MAURICE BUTLER, do hereby object to the de facto administrative hearing scheduled under color of law for May 3, 2023, due to lack of jurisdiction and improper service of process on the following grounds:

1. I am not identified as the alleged defendant in case number C-08-CR-23-000122. The alleged defendant, i.e., LAMONT MAURICE BUTLER (Race: Black), is an artificial fictitious corporate construct / nom de guerre / colored person which does not identify an actual natural person (human being) and constitutes fraud.
2. I was never given lawful service of process for case number C-08-CR-23-000122 in accordance with the prerequisite of due process of law under the 5th Amendment of the Constitution for the United States of America. I never received lawful notice of any ~~written~~ alleged written accusation being signed under oath or affirmation by the alleged plaintiff / injured party, which must be ^{an} identifiable natural person (human being) to have equal standing with me (and not an artificial person, e.g., STATE OF MARYLAND (Inc.)), so that I could have the opportunity to answer / respond.
3. I never made a general appearance in case number C-08-CR-23-000122 as the alleged defendant, LAMONT MAURICE BUTLER (Race: Black).


4. The private foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) is not a court of competent jurisdiction being ordained and established by Congress (via delegation of authority) under Article III, sections 1 and 2 of the Constitution for the United States of America, and cannot hear or decide any case or controversy involving me or my estate. On ~~April~~^{March} 6, 2023, the Affidavit of Fact: Default Judgment [Exhibit: A] was filed and entered in the records of case number C-08-CR-23-000122 as conclusive evidence, and ordered for the immediate dismissal with prejudice and closure of case number C-08-CR-23-000122 for lack of jurisdiction and fraud due to your failure to prove jurisdiction and you failed to execute your duty which constitutes your breach of duty by wanton negligence.

WHEREFORE, the de facto administrative hearing scheduled under color of law for May 3, 2023, and any other administrative hearing scheduled before and after that date in case number C-08-CR-23-000122 are unconstitutional, notwithstanding, null and void ab initio, and unenforceable, and shall be forthwith dismissed with prejudice and closed with case number C-08-CR-23-000122 for lack of jurisdiction, fraud, and improper service of process. See *Melo v. United States*, 505 F.2d 1026 ("Once jurisdiction is challenged, the court cannot proceed when it clearly appears that the court lacks jurisdiction, the court has no authority to reach merits, but, rather, should dismiss the action."). I will not be in attendance on May 3, 2023, for the above reasons.


