

RYAN DELEVAN CARTWRIGHT, after being duly sworn according to law, hereby depose and state the following:

1. That I am the freehold owner in allodium of my ancestral estate in reversion known to be located in the City of WASHINGTON, District of Columbia Republic, and more fully described as follows, to wit:

Lot 13 in Square 5387 in a subdivision made by Carr, Inc., et al. as per plat recorded in Liber No. 129 at Folio 8 among the Records of the Office of the Surveyor of the District of Columbia.

- That I inherited the above described ancestral estate in reversion as heir apparent by treaty right under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Empire of Morocco.
- 3. That my deceased ancestors are the ancient Moabites from the land of Moab who received permission from the Pharaohs of Kemet to settle and inhabit North-West Africa; they were the founders and are the true possessors of the present Moroccan

Empire, with their Canaanite, Hittite, and Amorite brethren who sojourned from the land of Canaan seeking new homes. Their dominion and inhabitation extended from North-East and South-West Africa, across the great Atlantis even unto the present North, South, and Central America and also Mexico and the Atlantis Islands; before the great earthquake, which caused the great Atlantic Ocean.

- 4. That my above described deceased ancestors retained reversionary interest in the allodium lands and resources of North America which the foreign United States of North America presently occupy and use in trust by usufruct under the expired fifty (50) year mandate, i.e. the Treaty of Peace and Friendship of 1836 between the United Sates of North America and the Empire of Morocco; which superseded the Treaty of Peace and Friendship of 1787 between the United States of America, and his Imperial Majesty the Emperor of Morocco; and which is still in force under the supremacy clause of the United States Republic Constitution Article VI, clause 2.
- 5. That my last known deceased ancestor was Charles Mosley Bey who was an indigenous Moorish American of North America, and who also retained reversionary interest in the above described ancestral estate in reversion. He recorded the pre-existing political status of the indigenous Moorish Americans of North America under registration number ©AA 222141, Class A, with the Clock of Destiny Moorish American National Identification Card and Zodiac Constitution, in the Library of Congress Copyright Office, Washington, District of Columbia, and the United States Department of Justice. I am a surviving heir apparent of Charles Mosley Bey by consanguinity, who died intestate in the year 1975. Therefore, I retain reversionary interest in the above described ancestral estate in reversion by inheritance. A copy of the Additional Certificate of

- 6. That the foreign DISTRICT OF COLUMBIA GOVERNMENT (Inc.) and subsidiaries are presently holding in escheat the above described estate in reversion, by their presumption of there being no competent legal heirs making claim thereto.
- 7. That upon the intestate death of my kin Charles Mosley Bey, I am hereby making adverse claim of title and reversion of estate to my above described ancestral estate in reversion as rightful heir apparent under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Empire of Morocco ("If an American Citizen shall die in our Country and no Will shall appear, the Consul shall take possession of his Effects, and if there shall be no Consul, the Effects shall be deposited in the hands of some Person worthy of Trust, until the Party shall appear who has a Right to demand them, but if the Heir to the Person deceased be present, the Property shall be delivered to him without interruption; and if a Will shall appear, the Property shall descend agreeable to that Will, as soon as the Consul shall declare the Validity thereof.").
- 8. That my treaty right to inherit and possess my above described ancestral estate in reversion cannot be denied or disparaged under color of any law as affirmed by 'stare decisis law' in the case Kolovrat v. Oregon, 366 U. S. 187, 194, 81 S.Ct. 922 (1961) where the Supreme Court of the United States stated, "A state cannot refuse to give foreign nationals their treaty rights because of fear that valid international agreements may possibly not work completely to the satisfaction of state authorities. Under the supremacy clause of the United States Constitution Art. VI, clause 2, state policies as to

- the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.".
- 9. That I, ex rel. RYAN DELEVAN CARTWRIGHT, did execute a Deed of Trust/Mortgage with a certain Samuell White, (acting as) Trustee, and BANK OF AMERICA, N.A., on August 26, 2013, pertaining to the above described estate in reversion. However, as of January 29, 2020, my signature on the Deed of Trust/Mortgage dated August 26, 2013, is rescinded nunc pro tunc via the Affidavit of Rescission of Signature [Exhibit: F] which is being filed with this adverse claim in case number 2019 CA 000509 R(RP) of the SUPERIOR COURT OF THE DISTRICT OF COLUMBIA (Inc.) on the grounds of fraud as explained therein. Therefore, the Deed of Trust/Mortgage dated August 26, 2013, and any attachments associated thereto are null and void ab initio.
- 10. I further aver that my ownership of the above described ancestral estate in reversion is and at all times will be in allodium as freeholder by allodial aboriginal title and inheritance per the above-mentioned treaty law, and I am therefore executing this Affidavit for the purpose of attesting to the truthfulness of the foregoing facts. Any other claim(s) of interest made against my above described ancestral estate in reversion are construed as spurious and void.


