

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Ryan Delevan
Cartwright-El (hereinafter "Judgment Creditor") shall recover forthwith from David A. Spector,

IT IS FURTHER ORDERED, that the signature of the Judgment Creditor on the Promissory Note dated August 26, 2013, and on the Deed of Trust/Mortgage dated August 26, 2013, are hereby rescinded for fraud, and such instruments are void ab initio and unenforceable;

IT IS FURTHER ORDERED, that a lien shall be placed against the real property known as 709 Burns Street, South East, Washington, District of Columbia, in order to secure the performance and payment of this judgment;

IT IS FURTHER ORDERED, that a lien shall be placed against the property and assets of the Judgment Debtors' in order to secure the performance and payment of this judgment, and the property and assets of the Judgment Debtors' are subject to levy after April 15, 2020, if

settlement of this judgment cannot be made between the Judgment Creditor and the Judgment Debtors' on or before such date;

IT IS FURTHER ORDERED, that the ancestral estate in reversion known as 709 Burns Street, South East, Washington, District of Columbia, hereby reverts to the Judgment Creditor without interruption, in allodium, as rightful heir and freeholder by allodial aboriginal title and inheritance after April 15, 2020, by the treaty right of the Judgment Creditor under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Empire of Morocco.
