Cordero, Pamela Hunter, David E. Solan, Howard N. Bierman, Kimberly Lawson, Patrick Decker, Milan Mittra, Jacob Geesing, David A. ORDERED AND ADJUDGED that a Writ of Error be and the same is hereby entered against the Respondents;

It is further ORDERED AND ADJUDGED that the foreign misrepresented instrument – bill of attainder / bill of exchange titled ORDER GRANTING MOTION TO RATIFY ACCOUNTING filed in the case on October 16, 2020, by Respondents, Laura A Cordero and Pamela Hunter, are NULL and VOID AB INITIO and are UNENFORCEABLE for lack of jurisdiction and fraud;

It is further ORDERED AND ADJUDGED that the collusive action and proceedings taken under color of law in case number 2019 CA 000509 R(RP) in the records of the foreign SUPERIOR COURT OF THE DISTRICT OF COLUMBIA (Inc.) by the Respondents are NULL and VOID AB INITIO for lack of jurisdiction and fraud.


