### Stare Decisis Law

The decision, judgment, opinion or rulings on former appeal or writ of error become "law of the case." See Massachusetts Bonding & Insurance Co. v. Banker's Surety Co., 96 Ind.App.250, 179 N.E. 329, 322; it expresses the rule that final judgement of highest court is final determination of parties' rights. See Atchison, T. & S. F. Ry. Co. v. Railroad Commission of California, 209 Cal. 460, 288 P. 775, 779.

IN THIS ACTION, Laura A. Cordero, (acting as) Administrative officer of the SUPERIOR COURT OF THE DISTRICT OF COLUMBIA (Inc.), issued the Judgment dated December 4, 2019, and the Order dated December 4, 2019, against the fictitious corporate person/nom de guerre RYAN DELEVAN CARTWRIGHT (cestui que trust estate) under color of law within purview of the 14<sup>th</sup> Amendment in an attempt to erroneously deprive me of my inheritance, i.e., my allodial private property – estate in reversion known as 709 Burns Street, South East, near corporate WASHINGTON, District of Columbia Republic, absent of the prerequisites of my due process rights secured under the 5<sup>th</sup> Amendment of the United States Republic Constitution, and absent of my treaty rights to consular jurisdiction under Articles 20 and 23 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Empire of Morocco.

It has been shown by the entry of the Affidavit of Fact: Notice of Default [Exhibit: C] being entered herewith and standing as prima facie evidence and conclusive proof of the Judgment dated December 4, 2019, and the Order dated December 4, 2019, being unconstitutional, null and void ab initio for lack of jurisdiction and fraud. See the stare decisis law in the case Elliot v. Peirsol, 26 U.S. 328, 340 (1828) where the Supreme Court of the United

States stated, "If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers."

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Laura A. Cordero, (acting as) Administrative officer, and Pamela Hunter, (acting as) Director of the SUPERIOR COURT OF THE DISTRICT OF COLUMBIA (Inc.), are in error;

IT IS FURTHER ORDERED, that the Judgment dated December 4, 2019, and the Order dated December 4, 2019, are unconstitutional, notwithstanding, null and void ab initio;

IT IS FURTHER ORDERED, that Laura A. Cordero, (acting as) Administrative officer, and Pamela Hunter, (acting as) Director of the SUPERIOR COURT OF THE DISTRICT OF COLUMBIA (Inc.), shall forthwith reverse ab initio and dismiss with prejudice the Judgment dated December 4, 2019, and the Order dated December 4, 2019, for lack of jurisdiction and fraud.
