Stare Decisis

See *United States v. Throckmorton*, 98 U.S. 61, 25 L.Ed. 93

("Fraud vitiates the most solemn contracts, documents, and even judgments."); and see *Elliot v. Peirsol*, 26 U.S. 328, 340 (1828)

("Courts are constituted by authority and they cannot act beyond the powers delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers.")

For the record, I am Lamont Maurice El, a natural person, in full life, in propria persona, sui juris. My nationality/citizenship is Moorish-American, being an aboriginal indigenous sovereign national to the land and de jure heir apparent thereof by jus sanguinis (Moslem of the west, widow's son), and foreign national inhabitant at LA PLATA, Maryland state republic.

I am the Consul General of Morocco, Maghrib al Aqsa, exercising consular jurisdiction at the Maryland state republic by authority given by treaty under Article 20 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, and I hereby make special appearance in case number C-08-CR-23-000122 as authorized representative, ex rel. LAMONT MAURICE BUTLER, and I object to the unconstitutional collusive action and de facto administrative proceedings under color of law in this alleged case; and to the void unconstitutional bills of attainder/foreign bills of exchange titled

WRIT OF SUMMONS- CRIMINAL dated February 28, 2023, with the attachment titled INDICTMENT bearing filed date February 27, 2023; and to the void de facto administrative hearing scheduled for March 24, 2023, due to lack of jurisdiction and fraud, and for the following errors:

1. the alleged defendant, i.e., LAMONT MAURICE BUTLER (Race: Black), is an artificial fictitious corporate construct/nom de guerre /straw-man (colored person) created by the unclean hands of others under color of law within purview of the unconstitutional 14th Amendment which does not identify an actual natural person (human being), and is being used for the purpose of fraud, denationalization, misrepresentation, identity theft, and kidnapping /human trafficking. See Exhibits: B1, B4, and B3 attached hereto. Furthermore, I do not consent to stand as surety for LAMONT MAURICE BUTLER (Race: Black) at any point, nor at any moment, nor at any time.
2. there is no actual identifiable natural person that has established the requirement of his or her standing as the alleged plaintiff/injured party, nor is there evidence of a written accusation being signed under oath or affirmation by the alleged plaintiff/injured party. See Allen v. Wright, 468 U.S. 737, 751 (1984) ("The requirement of standing, however, has a core component derived directly from the Constitution. A plaintiff must allege personal injury fairly traceable to the defendant's allegedly unlawful conduct and likely to be redressed by the requested relief."). The alleged plaintiff, i.e., STATE OF MARYLAND, is a private foreign corporation doing business under color of law within purview of the unconstitutional 14th Amendment

which also does not identify an actual natural person. Therefore, the alleged case number C-08-CR-23-000122 and the attachments associated thereto, including the unconstitutional bill of attainder instruments titled WRIT OF SUMMONS-CRIMINAL dated February 28, 2023, with the attachment titled INDICTMENT bearing filed date February 27, 2023, constitutes a collusive action under color of law for the purpose of fraud, conspiracy against rights, and deprivation of rights under color of law. See Exhibits: B1, B2, B4 and B3 attached hereto.

3. there is no evidence of lawful service of process given to the alleged defendant because the alleged defendant does not exist, and to make such a claim constitutes fraud. See Exhibit: B2 attached hereto.

4. the foreign de facto administrative agency, i.e., CIRCUIT COURT FOR CHARLES COUNTY (Inc.), operates under color of law by color of authority within purview of the unconstitutional 14th Amendment and does not have or possess lawful jurisdiction or Article III judicial authorization from Congress (delegation of authority order) to hear, present or pass judgment in any matter concerning my affairs, or in any dispute / case or controversy between a citizen of the United States and a Moor/Moorish-American, under a quasi criminal non-sanctioned tribunal of foreign private color of law process. Your lack of jurisdiction and fraud was proved by conclusive evidence in the related case number C-08-CR-22-000652 and in case number C-08-CR-21-000334 in the records of the foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) as explained in the memorandum below.

Memorandum

On or about June 22, 2022, you (including Amy J. Bragunier and Sharon L. Hancock both formerly acting as Administrative clerks) were duly served with lawful notice at your mailing address, either directly or by your agent, the certified copy of the Writ of Error and attached Certification Letter from me, which were truly taken and copied from the records of proceedings in the Morocco Consular Court at the Maryland State Republic on June 17, 2022, and entered in the records of case number C-08-CR-21-000334 of the foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) under consular jurisdiction. The Writ of Error stands in the record as conclusive evidence of the collusive action under color of law (i.e., STATE OF MARYLAND v. JERMAIN BOLDEN) and de facto administrative proceedings in case number C-08-CR-21-000334, including the de facto administrative hearing scheduled for July 14, 2022, and any other attachments associated thereto being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto.

On July 14, 2022, case number C-08-CR-21-000334 and the collusive action therein were dismissed with prejudice and closed for lack of jurisdiction and fraud.

On or about December 12, 2022, you (et al.) were duly served with lawful notice at your mailing address, either directly or by your agent, the ~~certified copy~~ Affidavit of Fact: Writ of Error [Exhibit: B] from me, which was entered in the records of related case number C-08-CR-22-000652 and stand as conclusive evidence of the misrepresented

instruments - bills of attainder / foreign bills of exchange titled WRIT OF SUMMONS - CRIMINAL dated December 5, 2022, with the attachment titled INDICTMENT bearing filed date December 2, 2022, and the collusive action under color of law (i.e., STATE OF MARYLAND v. LAMONT MAURICE BUTLER) and de facto administrative proceedings in related case number C-08-CR-22-000652, including the de facto administrative hearing scheduled for December 30, 2022, and any other attachments associated thereto being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you.

On or about January 6, 2023, you (et al.) were duly served with lawful notice at your mailing address, either directly or by your agent, the Affidavit of Fact: Writ of Error [Exhibit: C] from me, which was entered in the records of related case number C-08-CR-22-000652 and stand as conclusive evidence of the misrepresented instrument - bill of attainder / foreign bill of exchange titled CRIMINAL NOTICE OF HEARING / TRIAL dated December 29, 2022, and the de facto administrative hearings scheduled for February 3, 2023, March 3, 2023, March 31, 2023, and April 19, 2023, and any other attachments associated thereto in related case number C-08-CR-22-000652 being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you.

On or about January 6, 2023, you (et al.) were also duly served with lawful notice at your mailing address, either directly or by your agent, the Affidavit of Fact: Writ of Quo Warranto [Exhibit: D] from me, which was entered in the records of related case number C-08-CR-22-000652,

and stand as My special appearance therein, in full life, in propria persona, sui juris, as authorized representative, ex rel. LAMONT MAURICE BUTLER, and My jurisdictional challenge which commanded you to produce evidence of your alleged lawful jurisdiction and Article III judicial authorization from Congress (among a list of other things) and you were given three (3) days from that date to answer. You failed to answer which constitutes default and your default served as your admission by silence to your lack of jurisdiction and fraud.

On or about January 9, 2023, you (et al.) were duly served with lawful notice at your mailing address, either directly or by your agent, the Affidavit of Fact: Writ of Error [Exhibit: F] from me, which was entered in the records of related case number C-08-CR-22-000652 and stand as conclusive evidence of the misrepresented instrument-bill of attainder / foreign bill of exchange titled IA / Status dated December 30, 2022, and any other attachments associated thereto being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you.

On or about January 17, 2023, you (et al.) were duly served with lawful notice at your mailing address, either directly or by your agent, the Affidavit of Fact: Default Judgment [Exhibit: E] from me, which was entered in the records of related case number C-08-CR-22-000652 and ordered you to dismiss the case with prejudice along with any other attachments associated thereto for lack of jurisdiction and fraud due to your failure to answer the Affidavit of Fact: Writ of Quo Warranto [Exhibit: D] and prove jurisdiction. There was no cause to the contrary made thereto by you, however, you failed to execute your duty which constitutes your wanton

negligence and breach of duty.

On or about February 9, 2023, you were duly served with lawful notice at your mailing address, either directly or by your agent, the Affidavit of Fact: Writ of Error [Exhibit: H] from me, which was entered in the records of related case number C-08-CR-22-000652 and stand as conclusive evidence of the misrepresented instrument - bill of attainder / foreign bill of exchange titled NOTICE OF HEARING / TRIAL dated February 3, 2023, and the de facto administrative hearing scheduled for February 9, 2023, and any other attachments associated thereto being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you.

On or about February 16, 2023, you were duly served with lawful notice at your mailing address, either directly or by your agent, the Affidavit of Fact: Writ of Error [Exhibit: I] with attachment Exhibit: I1 from me, which was entered in the records of related case number C-08-CR-22-000652 and stand as conclusive evidence of the collusive action under color of law and de facto administrative proceedings in related case number C-08-CR-22-000652, including the de facto administrative hearing scheduled for February 21, 2023, and any other attachments associated thereto being unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you.

On or about February ²⁷28, 2023, you were duly served with lawful notice at your mailing address, either directly or by your agent, the

certified copy of the Writ of Error and attached Certification Letter from me, which were truly taken and copied from the records of proceedings in the Morocco Consular Court of the Maryland state republic on February 23, 2023, and entered in the records of related case number C-08-CR-22-000652 under consular jurisdiction. The Writ of Error stands in the record as conclusive evidence of the collusive action and de facto administrative proceedings under color of law in related case number C-08-CR-22-000652, including the de facto administrative hearings scheduled for March 10, 2023, and March 31, 2023, and April 19, 2023, and any other attachments associated thereto are unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. There was no cause to the contrary made thereto by you.

ORDER

WHEREFORE, it is hereby ORDERED and ADJUDGED that a writ of error be and the same is hereby entered against you, Monise A. Brown, James West, Lisa E. Yates, Jonathan Patrick Beattie, Tiffany L. Campbell, Michael Brown, and Anthony B. Covington;

It is further ORDERED and ADJUDGED that the misrepresented instruments-bills of attainder/foreign bills of exchange titled case number C-08-CR-23-000122, and titled WRIT OF SUMMONS-CRIMINAL dated February 28, 2023, with attachment titled INDICTMENT bearing filed date February 27, 2023, are unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud;

It is further ORDERED and ADJUDGED that the collusive action and de facto administrative proceedings under color of law in case number C-08-CR-23-000122 (and related case number C-08-CR-22-000652) in the records of the foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.), including

the de facto administrative hearing scheduled for March 24, 2023, and any other attachments associated thereto are unconstitutional, notwithstanding, null and void ab initio, and are unenforceable for lack of jurisdiction and fraud.


