I am in receipt of your misrepresented instrument - bill of  
attainder / foreign bill of exchange titled WRIT OF SUMMONS -

CRIMINAL dated December 5, 2022, being addressed to the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER (Race: Black), and the attachment thereto being another misrepresented instrument - bill of attainder / foreign bill of exchange titled INDICTMENT bearing the filed date December 2, 2022, also being addressed to the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER (Race: Black), and both being issued under color of law within purview of the unconstitutional 14<sup>th</sup> Amendment which constitutes fraud in the inducement.

Furthermore, your bill of attainder instruments titled WRIT OF SUMMONS-CRIMINAL dated December 5, 2022, and INDICTMENT bearing the filed date December 2, 2022, and any other attachments associated thereto are unconstitutional, notwithstanding, null and void ab initio for lack of jurisdiction and fraud for the following errors:

1. There is no identifiable natural person that has established the requirement of standing in case number C-08-CR-22-000652 as the plaintiff / injured party / victim, nor is there any conclusive evidence of a written accusation being signed under penalty of perjury by the same. The STATE OF MARYLAND (Inc.) is a private foreign de facto corporation which cannot contend or contest with a living natural person, which is why the alleged defendant is cited as the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER (Race: Black). This constitutes a collusive action taken under color of law for the purpose of fraud.
2. There is no evidence of a valid and verifiable contract or commercial agreement made between you or any representative of

the foreign CIRCUIT COURT FOR CHARLES COUNTY (Inc.) or the foreign STATE OF MARYLAND (Inc.) and I, which would obligate me to any specific performance or subject me to the color of any law, statute, code, rule, regulation, ordinance, custom, etc. being asserted in your bill of attainder instruments.

3. The private foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) and the representatives thereof, including you Lisa F. Yates, were not lawfully delegated judicial power or consular jurisdiction per Article III sections 1 and 2 of the Constitution for the United States of North America, and per Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire to hear and decide cases and controversies between any citizen of the United States and I, a free Moor / Moorish-American national.

4. There is no proof of lawful service of process being made upon I, Lamont Maurice El, a natural person, in full life, in propria persona, sui iuris.

Any alleged dispute or case made against me or my effects by any citizen of the United States can only be settled in a consular court of competent jurisdiction, e.g., Morocco Consular Court at the Maryland state republic, or by my consular officer, e.g., Nina Bey, per my secured treaty rights to consular jurisdiction and venue under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire, which is the supreme law of the land under Article VI clause 2 of the Constitution for the United States of North America. I do not

consent to anything to the contrary made thereto, nor do I waive or abandon any of my constitutional and treaty secured rights.

WHEREFORE, it is hereby ORDERED and ADJUDGED that a writ of error be and the same is hereby entered against you, Lisa E. Yates, Anthony B. Covington, Tiffany L. Campbell, Brian Moore, and any other representative of the foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) / STATE OF MARYLAND (Inc.) / CHARLES COUNTY SHERIFF DEPARTMENT (Inc.) being similarly situated;

It is further ORDERED and ADJUDGED that the misrepresented instruments - bills of attainder / foreign bills of exchange titled WRIT OF SUMMONS - CRIMINAL dated December 5, 2022, and INDICTMENT bearing the filed date December 2, 2022, and any other attachments associated thereto are unconstitutional, notwithstanding, null and void ab initio, and are unenforceable for lack of jurisdiction and fraud;


It is further ORDERED and ADJUDGED that the collusive action under color of law in the de facto case number C-DB-CR-22-000652, including the de facto administrative hearing set for December 30, 2022, and any other de facto hearing date set by you Lisa E. Yates and / or any representative of the foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) are unconstitutional, notwithstanding, null and void ab initio, and are unenforceable for lack of jurisdiction and fraud.

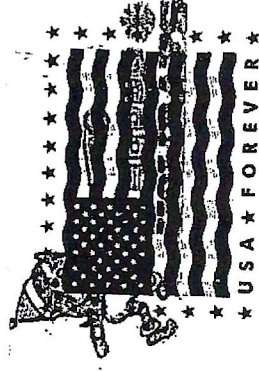

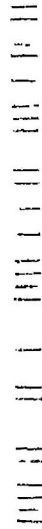
