Re: Misrepresented instrument - bill of attainder / foreign bill of exchange titled CRIMINAL NOTICE OF HEARING / TRIAL dated December 29, 2022, filed in de facto case no. C-08-CR-22-000652; and the void de facto administrative hearing dates scheduled for December 30, 2022, February 3, 2023, March 3, 2023, March 31, 2023, and April 19, 2023.

I am in receipt of another one of your misrepresented instruments - bills of attainder / foreign bills of exchange titled: CRIMINAL NOTICE OF HEARING / TRIAL dated December 29, 2022, addressed to the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER (Race: Black) under color of law within purview of the unconstitutional 14th Amendment which constitutes fraud in the inducement, and is held in law as unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. See United States v. Throckmorton, 98 U.S. 61, 25 L. Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments.").

On or about December 12, 2022, you were duly served (either directly or by and through your agent) with the Affidavit of Fact: Writ of Error [Exhibit: B] which was entered into the records of the de facto case no. C-08-CR-22-000652 and stands as conclusive evidence of the misrepresented instruments - bills of attainder / foreign bills of exchange titled WRIT OF SUMMONS - CRIMINAL dated December 5, 2022, and INDICTMENT filed on December 2, 2022, which were both addressed to the fictitious corporate person / nom de guerre LAMONT MAURICE BUTLER (Race: Black) under color of law within purview of the unconstitutional 14th Amendment, and any other attachment associated

thereto, including the de facto administrative hearing scheduled for December 30, 2022, to be unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud.

There was no cause to the contrary made thereto by you or any other representative of the private foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) or STATE OF MARYLAND (Inc.).

Nevertheless, on December 30, 2022, you, Monise A. Brown, acting in collusion with you, H. James West, Lisa E. Yates, Michael Brown, Tiffany L. Campbell, and Anthony B. Covington (et al.) proceeded with the void de facto administrative hearing under color of law, absent of proof of jurisdiction, and scheduled additional de facto administrative hearing dates for February 3, 2023, March 3, 2023, March 31, 2023, and April 19, 2023, by color of authority and in want of jurisdiction.

See *Hagan v. Levine*, 415 U.S. 533 ("The law requires proof of jurisdiction to appear on the record of the administrative agency and all administrative proceedings.").

Your wanton and untoward acts are based entirely under color of law via the foreign private de facto corporate Annotated Code of Maryland, being an unconstitutional bill of attainder in the form of the de facto case no. C-08-CR-22-000652 and the above-mentioned instruments filed therein by you (in collusion with others) which you use presently to kidnap me, rob me of my private and personal property/effects, denationalize me and hold me hostage for profit while keeping me deprived of my liberty as a prisoner-of-war under your custody in unlawful imprisonment (since November 13, 2022) against my consent, absent of a lawful 4th Amendment warrant and without due process of

law, but for the purpose of sale into slavery under the Black code color of law. See Constitution for the United States of North America Article I, section 10, clause 1 ("No state shall pass any bill of attainder."); and see Black's Law Dictionary, 5th Edition, definition of 'Bill of attainder' under 'Bill' ("Legislative act no matter what their form that applies either to named individuals or to easily ascertainable members of a group in such a way as to inflict punishment on them without a judicial trial."); and see Black's Law Dictionary, 5th Edition, definition of 'Name' ("A designation of a individual person, or a firm or corporation."); and see Black's Law Dictionary, 5th Edition, definition of 'Black code' ("A name given collectively to the body of laws, statutes, and rules enforced in various southern states prior to 1865 which regulated the institution of slavery, and particularly those forbidding their reception at public inns and on public conveyances."); and see Marbury v. Madison, 5 U.S. 137 (1803) ("If any statement, within any law which is passed, is unconstitutional, the whole law is unconstitutional.").

WHEREFORE, it is hereby ORDERED and ADJUDGED that a writ of error be and the same is hereby entered against you, Monise A. Brown, H. James West, Lisa E. Yates, Michael Brown, Tiffany L. Campbell, and Anthony B. Covington;

It is further ORDERED and ADJUDGED that the misrepresented instrument - bill of attainder / foreign bill of exchange titled CRIMINAL NOTICE OF HEARING / TRIAL dated December 29, 2022, and any other attachments associated thereto are unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud;

It is further ORDERED and ADJUDGED that the collusive

action under color of law in the de facto case no. C-08-CR-22-000652, including the de facto administrative hearing held on December 30, 2022, and scheduled for February 3, 2023, March 3, 2023, March 31, 2023, and April 19, 2023, are unconstitutional, notwithstanding, null and void ab initio, and are unenforceable and cancelled for lack of jurisdiction and fraud.



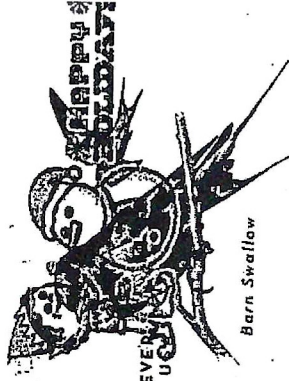
