Memorandum

On December 30, 2022, you, Monise A. Brown and Lisa E. Yates, acting in collusion with you, Johnathan Beattie and Anthony B. Covington, filed in the records of de facto case no. C-08-CR-22-000652 another misrepresented instrument - bill of attainder / foreign bill of exchange titled IA / Status dated December 30, 2022, being addressed to the fictitious corporate

person/nom de guerre named LAMONT MAURICE BUTLER (Race: Black) under color of law within purview of the unconstitutional 14th Amendment which constitutes fraud in the inducement, and such instrument is held in law as unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. See Constitution for the United States of North America, Article 1, section 9, clause 3 ("No Bill of Attainder shall be passed."); and Article 1, section 10, clause 1 ("No state shall pass any bill of attainder."); and see United States v. Throckmorton, 98 U.S. 61, 25 L.Ed. 93 ("Fraud vitiates the most solemn contracts, documents, and even judgments.").

WHEREFORE, it is hereby ORDERED and ADJUDGED that a writ of error be and the same is hereby entered against you, Monise A. Brown, Lisa E. Yates, Johnathan Beattie, and Anthony B. Covington;



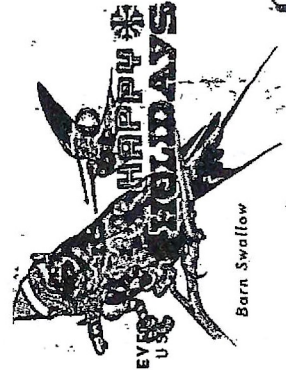
