Re: Misrepresented instrument - bill of attainder / foreign bill of exchange styled
as de facto case no. C-08-CR-22-000652.

For the record, I am Lamont Maurice El, Moslem of the west (Widow's
son), original inhabitant of the land, natural person, in full life, in propria
persona, sui juris. My nationality / citizenship is Moorish-American (a free
Moor), being an aboriginal sovereign national and heir of the present Moroccan
Empire. I hereby make special appearance as authorized representative, ex
rel. LAMONT MAURICE BUTLER (a fictitious corporate person) under protest,
and I hereby challenge your jurisdiction for reasons of lack of jurisdiction,
fraud, and improper venue.

Jurisdiction and Venue

I hereby invoke and assert my secured treaty rights to consular
jurisdiction and venue under Articles 20, 21 and 22 of the Treaty of Peace
and Friendship of 1836 between the United States of North America and the
Moroccan Empire. See *Kolovrat v. Oregon*, 366 U.S. 187, 194, 81 S.Ct. 922 (1961)
("A state cannot refuse to give foreign nationals their treaty rights because of
fear that valid international agreements may possibly not work completely to
the satisfaction of state authorities. Under the supremacy clause of the

United States Constitution Article VI, clause 2, state policies as to the rights of aliens to inherit must give way to overriding federal treaties and conflicting arrangements.").

Memorandum

On November 13, 2022, near foreign corporate LA PLATA, Maryland state republic, I was arbitrarily kidnapped, sexually assaulted via strip search, robbed of my private and personal property/effects, denationalized and deprived of my liberty while being held hostage for profit as surety for the fictitious corporate person/nom de guerre named LAMONT MAURICE BUTLER (Race: Black) as a prisoner-of-war under color of law at the private foreign de facto concentration camp known as CHARLES COUNTY DETENTION CENTER (Inc.) by several armed foreign hybrid European highwaymen identified as C. Cooley #710, Garner #545, Morrison #615, McPherson #331, Hawkins #408, and Halterman^{#732} (in collusion with Brian Moore #512, et al.) acting as policemen/commercial mercenaries/employees/contractors of the private foreign de facto CHARLES COUNTY ~~DETENTION CENTER~~ SHERIFF DEPARTMENT (Inc.) against my consent, absent of a lawful warrant and without due process of law in violation of Article III section 2, and the 4th and 5th Amendments of the Constitution for the United States of North America, and in violation of Articles 6, 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire.

Since November 13, 2022, unto this present date, I am still being denationalized and deprived of my liberty under your custody pursuant to the misrepresented instruments - bills of attainder / foreign bills of exchange styled as case no. C-08-CR-22-000652, and titled INDICTMENT filed on December 2, 2022, and titled WRIT OF SUMMONS - CRIMINAL dated

December 5, 2022, and titled CRIMINAL NOTICE OF HEARING/TRIAL dated December 29, 2022, which were issued by you, Monise A. Brown, Lisa E. Yates, Tiffany L. Campbell, and Anthony B. Covington, in collusion with you, H. James West, Michael Brown, Troy D. Berry, and Brandon Foster, under color of law by color of authority within purview of the unconstitutional 14th Amendment, and addressed to the fictitious corporate person / nom de guerre named LAMONT MAURICE BUTLER (Race: Black), and are unconstitutional, notwithstanding, null and void ab initio, and unenforceable pursuant to Article I, section 9, clause 3 ("No bill of attainder shall be passed."), and Article I, section 10, clause 1 ("No state shall pass any bill of attainder.") of the Constitution for the United States of North America.

Quo Warranto

YOU ARE HEREBY COMMANDED to produce the following as proof beyond reasonable doubt of your lawful jurisdiction and judicial authorization:

1. evidence of a delegation of authority order from Congress per Article III, sections 1 and 2 of the Constitution for the United States of North America as proof of you, Monise A. Brown, H. James West, and Lisa E. Yates, and any other representative (acting as Administrative clerk) of the private foreign de facto CIRCUIT COURT FOR CHARLES COUNTY (Inc.) being lawfully conferred judicial power and consular jurisdiction to hear and decide cases and controversies / disputes between Moors (Moorish-Americans) and citizens of the United States authorized under Articles 20 and 21 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire;
2. evidence of an alleged identifiable natural person that has established standing as plaintiff / injured party / victim, with an alleged written

accusation signed under oath or affirmation by the same (see *Allen v. Wright*, 468 U.S. 737, 751 (1984) "The requirement of standing, however, has a core component derived directly from the Constitution. A plaintiff must allege personal injury fairly traceable to the defendant's allegedly unlawful conduct and likely to be redressed by the requested relief.");

3. evidence of an alleged lawful 4th Amendment arrest, search and seizure warrant being signed and issued by a consular officer or Article III judicial officer as your lawful authorization to deprive me of my liberty and privacy, and hold my private and personal property/effects under your custody against my consent;

4. evidence of a valid and verifiable contract or commercial agreement mutually made between you and/or any other representative of the private foreign de facto STATE OF MARYLAND (Inc.) or CIRCUIT COURT FOR CHARLES COUNTY (Inc.) or CHARLES COUNTY DETENTION CENTER (Inc.) and I, which would obligate me to any specific performance or subject me to the color of any law, statute, code, rule, regulation, or custom of the private foreign de facto STATE OF MARYLAND (Inc.) (including the unconstitutional bill of attainder known as 'Annotated Code of Maryland');

5. evidence of me identifying myself as LAMONT MAURICE BUTLER (Race: Black) or consenting to stand as surety for the same while being of sound mind at any point, or any moment, or any time;

6. evidence of your lawful service of process upon me regarding de facto case no. C-08-CR-22-000652 and any of your filings therein.

Days to Answer

You (all) have three (3) days from the received (or filed) date of you, Lisa E. Yates, to answer and produce the above evidence for the record

in its entirety and to rebut the above memorandum, point-by-point, on an affidavit signed under penalty of perjury.

Default

Failure to answer as described above constitutes default, and serves as your admission by silence to the above memorandum and your lack of the above listed evidence which proves your lack of jurisdiction and lack of judicial authorization; and your bill of attainder styled as de-facto case no. C-08-CR-22-000652 and all of your bill of attainder instruments mentioned above are unconstitutional, notwithstanding, null and void ab initio, and unenforceable for lack of jurisdiction and fraud. Upon your default, you are obligated to me for the following redress, including the immediate dismissal with prejudice and closure of de-facto case no. C-08-CR-22-000652 and any attachments associated thereto and my immediate and unconditional release from unlawful imprisonment.





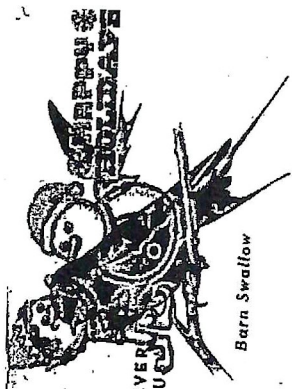
