**Stare Decisis Law**

See **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*)

I am in receipt of your misrepresented instrument - bill of attainder / foreign bill of exchange titled NOTICE OF INTENT TO FORECLOSE dated on May 14, 2024 account number [REDACTED] 835 which does not bear a name or a signature from the sender, nor is there an identifiable natural person claiming to be the alleged creditor in such instruments. Also, your instruments are addressed to the fictitious corporate person / nom de guerre [REDACTED] WILKINSON (race: black) under color of law within purview of the unconstitutional 14th Amendment.

Furthermore, on February 23, 2024, you were served process at your present address via United States Postmaster – certified mail (article number 9589 0710 5270 1010 8935 80) with the Affidavit of Dispute, the Affidavit of Fact: Adverse Claim of Title and Reversion of Ancestral Estate and Memorandum of Trust, and you were given five (5) days from that date as an opportunity to answer and produce the evidence which proves your claim. Since then, you failed to answer which constitutes default.

On April 25, 2024, you were served process at your present address via United States Postmaster – certified mail (article number 9589 0710 5270 1425 2535 59 and 9589 0710 5270 1425 2535 66) with the Affidavit of Fact: Notice of Default and Affidavit of Fact: Notice of Error which stands as conclusive evidence of your admission by silence to you being guilty of fraud and swindles under Title 18 USC 1341; and conclusive proof of you having no valid claim, and the alleged debt associated with account number [REDACTED] 835 was fully paid and discharged in pursuance of and in reliance on Title 12 USC 95a(2).

Wherefore, your spurious instrument titled NOTICE OF INTENT TO FORECLOSE dated May 14, 2024, and any other attachments associated thereto are ERRONEOUS, NULL and VOID AB INITIO and are UNENFORCEABLE for fraud in the inducement, see Exhibit: D1; and any and all



other spurious instruments that I receive from you and / or any other representative or contractor for the foreign de facto SANTANDER CONSUMER USA (Inc), being associated with account number [REDACTED] 835 are void ab initio for fraud and will be ignored.

Pursuant to 15 USC 1692(a) you are knowingly engaging in abusive, deceptive, and unfair alleged debt collection practices contributing to invasion of privacy. Pursuant to 15 USC 1692(c) without the express permission of a court of competent jurisdiction, you may not communicate with me in connection with the collection of any alleged debt. You have been served notice of my status, nationality, and the appropriate consular jurisdiction in which you are lawfully obligated to respond. Therefore, each correspondence from you is deemed an inconvenience and violation of 15 USC 1692(c)(a)(1). Pursuant to 1692(c)(c) you are commanded to cease and desist all communications with exception to notify of a remedy.

You are in violation of 15 USC 1692(d) you must not harass, oppress, or abuse me or my estate in connection with the collection of an alleged debt. You are harming me and my estate physically and mentally. You are harming my reputation by way of your fraudulent reporting to credit reporting agencies. Your correspondences use obscene and profane language against me and my estate used to dehumanize and denationalize. As well, as your misrepresented instrument bill of attainder / foreign bill of exchange titled as a NOTICE OF INTENT TO FORECLOSE dated May 14, 2024 account number [REDACTED] 835; known as [REDACTED] [REDACTED] you are in violation of 15 USC 1692(d)(4) in which you are stating the intent to advertise for sale of any alleged debt to coerce payment of the alleged debt.

You are in violation of 15 USC 1692(e) as you are using false, deceptive, and misleading representation or means in connection with the collection of an alleged debt. You are in violation of 15 USC 1692(e)(2) because you are misrepresenting the character, amount, and legal status of the alleged debt. Your misrepresented instrument bill of attainder / foreign bill of exchange titled as a NOTICE OF INTENT TO FORECLOSE dated May 14, 2024 account number [REDACTED] 835; known as [REDACTED] [REDACTED] are in violation of 15 USC 1692(e)(4) as you are threatening seizure of property on my ancestral estate. You are in violation of 15 USC 1692(e)(5) because you are threatening to take actions that cannot legally be taken. You are in violation to 15 USC 1692(e)(8) as you are communicating and threatening to

communicate credit information which is known or which should be known to be false, including the failure to communicate that a disputed alleged debt is disputed.

Because you have been unable to validate your claim, the alleged debt is void ab initio for fraud. Therefore you are in violation of 15 USC 1692(f)(1). You must not pursue the collection of any amount (including any interest, fee, charge, or expense incidental to the principal obligation) unless such amount is expressly authorized by the agreement creating the alleged debt or permitted by law. You are in violation of 15 USC 1692(f)(6) because you are threatening to take nonjudicial action to effect dispossession or disablement of property. You are in violation of 15 USC 1692(f)(6)(A) because there is no present right to possession of the property claimed as collateral through an enforceable security interest. You are in violation of 15 USC 1692(f)(6)(C) because the property is exempt by law from such dispossession or disablement.

Pursuant to 15 USC 1692(g)(b) upon receipt of this notice you must immediately cease and desist all collection of the alleged debt as you have neglected to provide a validation of your claim. Pursuant to 15 USC 1681i(5) (A)(i) you must promptly delete the alleged debt being associated with account number [REDACTED] 835. Pursuant to 15 USC 1681(b)(6)(2)(A)(ii) **all alleged and assumed authorization to communicate any reporting about me or my ancestral estate is revoked with all signatures rescinded.**



## ACT NOW TO AVOID LOSING YOUR HOME TO FORECLOSURE OTRO LADO PARA INFORMACIÓN EN ESPAÑOL

Dear Maryland Homeowner:

According to our records, you may have recently received in the mail or will soon receive a **Notice of Intent to Foreclose (NOI)** from the company that you send your mortgage payments to – this company is called a “mortgage servicer”. You are receiving an NOI from your mortgage servicer because you have missed one or more payments or otherwise not repaid your loan as agreed (also known as being “in default”). If your loan is more than 90 days in default, a foreclosure action can be filed in court as soon as 45 days from the date that the NOI was sent to you.

The Maryland Office of the Commissioner of Financial Regulation (OCFR) wants you to know that there are options and free resources available for homeowners facing foreclosure, but you must act now.

1. **Contact your mortgage servicer immediately, even if you believe your loan is current, and ask about your options to avoid foreclosure.**
  - Open all mail, promptly respond to phone messages, and provide any requested documents to your mortgage servicer or the law firm representing them.
  - You may be entitled to a mediation session with your mortgage servicer or their representative. If you receive a “Request for Mediation” form, return it to the court as soon as possible to schedule the mediation.
2. **Visit the website [homeownerassistance.maryland.gov](http://homeownerassistance.maryland.gov) for Maryland’s foreclosure prevention information.**
  - The Maryland Homeowner Assistance Fund may be able to help if you are at risk of foreclosure due to a COVID-19 related financial hardship. See the website above or call 1-833-676-0119 to check your eligibility.
  - Call the Maryland Homeowner Assistance hotline at 1-877-462-7555 for a referral to a nonprofit housing counseling agency or legal services agency near you. A housing counselor can help you understand your options to avoid foreclosure and assist with communicating with your mortgage servicer, *at no cost to you*. You may also qualify for free or reduced rate legal services from an attorney.
3. **Beware of fraudulent “mortgage assistance relief” services and other foreclosure-prevention scams.**
  - DO NOT PAY anyone a fee in advance to assist you with a loan modification.
  - DO NOT SEND your mortgage payments to anyone other than your mortgage servicer.




