

Memorandum

On September 13, 2024, this Consular Court issued a Default Judgment under consular jurisdiction which was entered in the records of related case number C-16-CV-23-002644 of the foreign de facto CIRCUIT COURT FOR PRINCE GEORGE'S COUNTY (Inc.) on September 26, 2024, against the Defendants Gladys M. Weatherspoon and Mahasin El Amin, and in favor of Charis Wilkinson-Bey (another Moorish-American national under our consular jurisdiction), having a judgment of \$3,022,000 for compensatory damages due to the injurious acts caused by defendants Gladys M. Weatherspoon and Mahasin El Amin (et al.), which includes fraud and want of jurisdiction. The defendants in this case, including Gladys M. Weatherspoon and Mahasin El Amin, have committed the same type of injurious acts against the Complainant Robert McKinney-El in

their attempt to deprive him of his treaty right to inherit his ancestral estate in reversion known as Maryland.

Wherefore, it is this 22nd day in the month of October, 2024, in this Morocco Consular Court at the Maryland state,

ORDERED AND ADJUDGED that a default judgment be and the same is hereby entered against the Defendants Robin D. Gill Bright, Gladys M. Weatherspoon, Mahasin S. El Amin, Elizabeth Coleman Jones, Nikita Fain, John Alexander Nader, and Peter D. Sullivan (hereinafter "Judgment Debtors");

It is further ORDERED AND ADJUDGED that Complainant Robert McKinney-El (hereinafter "Judgment Creditor") shall recover from the Judgment Debtors the judgment as follows:

- The immediate dismissal with prejudice of case number CAEF22-26634 and any other attachments associated thereto for lack of jurisdiction and fraud;
- ii. The total principal amount of \$3,022,000 payable in lawful money of .9999 fine silver bullion coins and / or bars due forthwith;

It is further **ORDERED AND ADJUDGED** that a judgment lien be and the same is hereby entered against the oaths of office, surety bonds, and all property (real and personal; corporeal and incorporeal) and assets of the Judgment Debtors and their spouse, their heir(s), successor(s), and assign(s) in order to secure the performance of this judgment, and to levy on such property and assets for the satisfaction of this judgment if payment cannot be made by the Judgment Debtors;

It is further **ORDERED AND ADJUDGED** that judgment for possession of the estate in reversion known as Maryland, (and more fully described in the Affidavit.)

of Fact: Adverse Claim of Title and Reversion of Ancestral Estate [Exhibit: A]) is hereby delivered without interruption to the Judgment Creditor, in allodium, as rightful heir and reversioner owner by aboriginal title pursuant to his treaty right to inherit under Article 22 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire.


