### **Stare Decisis Law**

*"Courts are constituted by authority and they cannot act beyond the power delegated to them. If a court acts without authority, its judgments and orders are regarded as nullities. They are not voidable, but simply void; and form no bar to a remedy sought in opposition to them, even prior to a reversal. They constitute no justification; and all persons concerned in executing such judgments, or sentences, are considered, in law, as trespassers." See Elliot v. Peirsol, 26 U.S. 328, 340 (1828)*

It has been brought to my attention via online Maryland case search (<https://casesearch.courts.state.md.us/casesearch/inquiry-index.jsp>) that there was a misrepresented instrument – bill of attainder / foreign bill of exchange titled Judgment Awarding Possession filed on August 26, 2024, in the collusive action under color of law within purview of the unconstitutional 14th Amendment in case number C-16-CV-23-002644 against the fictitious corporate person / nom de guerre CHARIS WILKINSON (Race: Black), which constitutes fraud. See **United States v. Throckmorton**, 98 U.S. 61, 25 L.Ed. 93 (*"Fraud vitiates the most solemn contracts, documents, and even judgments."*).

Furthermore, it has been proved that the foreign de facto CIRCUIT COURT FOR PRINCE GEORGE'S COUNTY (Inc.) was never lawfully delegated judicial authorization from Congress under Article III, section 1 and 2 of the Constitution for the United States of North America to hear and decide 'diversity of citizenship' cases between Moorish-Americans and citizens of the United States. Conclusive evidence of your lack of jurisdiction are shown in the records of case number C-16-CV-23-002644, i.e., the un rebutted Affidavit of Fact: Writ of Quo Warranto [EXHIBIT: A] entered on January 10, 2024; the un rebutted Affidavit of Fact: Default Judgment [EXHIBIT: C] entered on January 23, 2024; the un rebutted Affidavit of Fact: Writ of Error [EXHIBIT: D] entered on January 23, 2024; and the un rebutted Affidavit of Fact: Writ of Error [EXHIBIT: E] entered on April 17, 2024. See *Elliot* case mentioned above.

**WHEREFORE**, it is considered **ORDERED AND ADJUDGED** that a writ of error be and the same is hereby entered against you, Gladys M. Weatherspoon, Mahasin El Amin, Jeffrey Nadel, Scott Nadel, and Daniel Menchel;

It is further **ORDERED AND ADJUDGED** that the misrepresented instrument – bill of attainder / foreign bill of exchange titled Judgment Awarding Possession dated August 26, 2024, filed by Gladys M. Weatherspoon, and any other attachments associated thereto are **UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO**, and are **UNENFORCEABLE** for lack of jurisdiction and fraud;

It is further **ORDERED AND ADJUDGED** that the collusive action and de facto administrative proceedings in case number C-16-CV-23-002644 in the records of the foreign **CIRCUIT COURT FOR PRINCE GEORGE'S COUNTY (Inc.)**, including the de facto colorable auction held on February 13, 2024, are **UNCONSTITUTIONAL, NOTWITHSTANDING, NULL and VOID AB INITIO** and are **UNENFORCEABLE** for lack of jurisdiction and fraud.
