# ARTICLES OF INCORPORATION OF PINEWOOD GARDENS CIVIC LEAGUE A Virginia Nonstock Corporation

#### Article I - Name

The name of the corporation is Pinewood Gardens Civic League.

### Article II - Type of Corporation

This corporation is a nonstock corporation organized under Chapter 10 of Title 13.1 of the Code of Virginia, known as the Virginia Nonstock Corporation Act.
