

Privacy Policy

At MedGuard Protection Plans (“MedGuard”), we take protecting your privacy seriously. This Privacy Policy applies to www.medguardplans.com and its parent company website: www.usmedic.com (collectively “MedGuard Websites”) and governs data collection and usage. By using the MedGuard Websites, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the MedGuard Websites. These may include: (a) registering for an account on the MedGuard Websites; (b) signing up for special offers from selected third parties; and (c) sending us an email message. In such events, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. Sharing Information with Third Parties

MedGuard may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on MedGuard or the site; (b) protect and defend the rights or property of MedGuard; and/or (c) act under exigent circumstances to protect the personal safety of users of MedGuard, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by MedGuard. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the MedGuard website.

Children Under Thirteen

MedGuard does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
