

Privacy Policy

At U.S. Medical Equipment Consultants, Inc. (“US MEDIC”), we take protecting your privacy seriously. This Privacy Policy applies to www.usmedicplans.com, www.usmedic.com and www.usmedicportal.com (collectively “US MEDIC Websites”) and governs data collection and usage. By using the US MEDIC Websites, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the US MEDIC Websites. These may include: (a) registering for an account on the US MEDIC Websites; (b) signing up for special offers from selected third parties; and (c) sending us an email message. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by US MEDIC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the US MEDIC website.

Children Under Thirteen
