- A. 2023 Highlights by Meg Duhr
  - 1. Speech from County Commissioner Rafael Ortega highlighting investments in the West 7<sup>th</sup> neighborhood, especially in housing and public safety.
  - Speech from Saura Jost, Ward 3 Rep, highlighting work of her office, including Riverview Corridor project, Lead Free program, and libraries. She also shared some notes from Rebecca Noecker, Ward 2 Council member. Priorities for her this year include affordable housing and increasing housing density, supporting commercial corridors, and helping St. Paul families afford childcare.
  - 3. Speech from Meg outlining what the District Council is, what it does, and the vibrant history of the Fort Road Fed. Outlined what the FRF has done since our last annual meeting. Encouraged folks to vote for the Jefferson Avenue traffic calming measures to receive the 2024 Capital Improvement Budget grant. Encouraged attendees to attend Riverview Corridor West 7<sup>th</sup> Community Values Meeting (June 4 from 6-8 pm at CSPS Hall). Commented on erosion of community spaces such at Keg & Case, Rathskeller, and the Waterford site.
