I WAS CAPTURED ONLY DAYS LATER, ON 9-OCT-1994 (MY 27 TH BIRTHDAY), ON ROUTE TO DELIVERING A DESPERATE LETTER TO ANGIE (WHOM WAS VOWING TO COMMIT SUICIDE IF I WERE KILLED). THE POLICE FOUND AND CALLED IT MY "SUICIDE NOTE". IT INCLUDED, QUOTE: "MY PRECIOUS ANGELA: I BEG FOR YOUR UNDERSTANDING AND FORGIVENESS SWEETHEART... I KNOW YOU DON'T AGREE WITH MY ESCAPING, YET I FELT I HAD NO CHOICE. AS IT WAS, I WAS HALF-DEAD AND UNLIKELY TO SURVIVE... PLEASE DON'T FALL APART OR THINK OF DOING ANYTHING TO YOURSELF." I WAS CONVINCED THAT I WOULD BE SHOT DEAD AT ANY MOMENT.

96 (29)	Sentence for 94 crimes to 12-YEARS, extending my sentence to 21-YEARS. Millhaven Prison, J-UNIT.	
97 (30)	(KP) Forced into Kingston Pen. (until 2010). Staff implicated in the Sharif Scandal also came to KP.	
98 (31)	(KP) KP-CSC targeted, abused and tortured us in every which way. It's amazing we even survived.	
99 (32)	(KP) Angie became officially "DISABLED" due to the endless attacks by KP-CSC upon even her.	
00 (33)	(KP) Parole denied. Isolated due to KP-CSC's proven "conspiracy to commit murder" sham.	
01 (34)	(KP) Angie and I made our common-law marriage more official with a minister. I attempted suicide.	
02 (35)	(KP) Parole denied. Angie attempted suicide when I tried forcing her to leave me and save herself.	
03 (36)	(KP) The attacks upon us were relentless as we tried to stand up for ourselves.	
04 (37)	(KP) In my view, KP-CSC WRONGLY-IMPRISONED ME for the next 6-YEARS, mostly in ISOLATION in KP.	HOWEVER SERIOUS MY OWN CRIMES WERE, AND NO MATTER HOW SEVERELY PREJUDICED, KP-CSC, COULD ONLY REPORT, QUOTE: "THERE IS NO VALID INFORMATION THAT WOULD SUGGEST THAT 'SERIOUS HARM' TO ANY VICTIM EITHER OF A PHYSICAL OR PSYCHOLOGICAL NATURE WAS INCURRED." ALSO, THAT I HAD NO SEXUAL OR DRUG RELATED RECORD OR PROBLEM. YET, I WAS UNJUSTLY DETAINED FOR THE ENTIRE "6 YEARS" OF MY SUPPOSED STATUTORY RELEASE - IN MAXIMUM-SECURITY KP, AND MOSTLY ISOLATED FOR NO WRONG-DOING ON MY PART.
05 (38)	(KP) Unjustly imprisoned & isolated to no end, I started using morphine to cope with the pain	
06 (39)	(KP) My father visited me for the first and last time.	WHEN MY FATHER CAME FROM PORTUGAL AND VISITED ME (HE DID NOT TELL ME THAT HE WAS DYING OF CANCER), I FINALLY HAD MY OPPORTUNITY TO ASK HIM THE QUESTION THAT HAD HAUNTED ME MY ENTIRE LIFE: "AT AGE 15, WHAT DID I DO TO YOU THAT WAS SO WRONG THAT YOU SO VICIOUSLY ATTACKED AND ACTUALLY TRIED TO KILL YOUR OWN SON?" HE JUST LOOKED AT ME AND SHRUGGED IT OFF WITH, "OH, YOUR FATHER JUST WASN'T THINKING RIGHT AT THAT TIME!" NOT EVEN AN APOLOGY AND HE JUST MOVED ON TO ANOTHER SUBJECT.
07 (40)	(KP) Father died (cancer). Parole denied. Tried to file Habeas Corpus wrongful imprisonment, no \$.	
08 (41)	(KP) Attempt to file civil actions against KP-CSC... could not afford the fees and had to cancel.	
09 (42)	(KP) 3-Dec. Released from prison officially DISABLED and on the METHADONE PROGRAM.	
10 (43)	Kingston. Very damaged.	
11 (44)	Toronto. Working. Lost baby. Mental & addictions breakdown. Suicide attempt. Imprisoned.	
12 (45)	In CNCC (super-jail in Napanee). My mom died on 12-Nov. (cancer).	
13 (46)	10-Jan: Sentenced to 2-years less a day... 18-April: OCI, my first time getting any real treatment.	
14 (47)	I will be RELEASED from OCI on 12-May ("good time"). Start 3-years of very strict PROBATION.	
15 (48)	8-Jan: Expiry of my current sentence.	
16 (49)	End of my probation.
