### From the North

From I 71 use exit 117 for Dublin Granville Rd, Route 161. Turn right onto Dublin Granville Rd. Turn right onto Busch Blvd. Turn right onto Kingsmill Parkway and continue until it dead ends into the hotel parking lot.

### From the South

From I 71 use exit 117 for Dublin Granville Rd, Route 161. Turn left onto Dublin Granville Rd. Turn right onto Busch Blvd. Turn right onto Kingsmill Parkway and continue until it dead ends into the hotel parking lot.

### From the East

From I 270 North to exit 27, Cleveland Ave. Turn right and immediately get into left lanes. Turn left onto Schrock Rd. Go 2.5 miles and turn left on Doubletree Ave and the hotel will be visible on the left.

### From the West

From I 70 East to I 270 North to I 71 South. Use exit 116 for Dublin Granville Rd, SR 161. Turn right onto Dublin Granville Rd. Turn right onto Busch Blvd. Turn right onto Kingsmill
