2. Selection of the candidates will be based on screening by the scientific committee and the merit based on the peer review report.
3. This fellowship has stringent qualifying regulations, and will test the knowledge proficiency of the candidate. The fellowship does not intend to or cannot endorse individual's skill or proficiency with clinical execution of the acquired or existing knowledge.
4. All the applications submitted to DAMER, India will be subjected to preliminary screening and a peer review process.
5. Only preliminary selected candidates will be considered for the grant of the fellowship, provided they comply with the requirements.
6. Only the selected applicants will be issued the certificate of fellowship, at the completion of the requirements and evaluations.
7. The fellowship will be awarded ONLY to the qualified candidates as declared by the jury.
8. Submitting the application or application fee is no guarantee of selection or award of fellowship.
9. The fellowship fee is non-refundable, under any circumstances.
10. Non-compliance with instructions or failure to qualify the evaluation process, will lead to disqualification, at any stage of the programme. The fee is non-refundable on disqualification.
11. It will be mandatory and binding for the candidate to publish two scientific papers in the pubmed/scopus indexed journals "related to temporomandibular joint and its disorders/ management" before the fellowship grant. It should be clearly mentioned in the published papers/ scientific publication as declaration that the publication is a part of the fellowship program from DAMER, India, TMJ Foundation and TMJ Consultancy in the following format: "**Declaration:** The publication is a part of and is a partial requirement for the fellowship program on temporomandibular joint disorders (FTMJF) of the TMJ Foundation, TMJ Consultancy Services, Bhopal (Madhya Pradesh), India and DARSN Academy for Maxillofacial Education and Research, DAMER, India."
12. All the decisions taken by the DAMER, India will be final and binding.
13. All the selected candidates will have to submit a short library dissertation on a topic of their interest in the subject of temporomandibular joint, online for the peer review and approval by DAMER, India for the fellowship grant. The submitted work should be original.

6. Submission of short library dissertation (within six months after enrolment)
7. Publication of two scientific papers in scopus/pubmed indexed journals “related to temporomandibular joint and its disorders/ management” after the enrolment process, before the grant of fellowship.
