- 2. Shipping dates are approximate and are dependent upon prompt receipt of all necessary information by All Metro Electrical Distributors. All Metro Electrical Distributors shall not be liable for late delivery due to fire, strike, civil or military authority, insurrection or riot, unavailability of material or parts, and for other causes beyond is reasonable control, and All Metro Electrical Distributors shall not be liable for incidental or consequential damages arising from late delivery.
- 3. All equipment and supplies shall be installed by and at the expense of the Purchase run less otherwise stipulated in writing. All Metro Electrical Distributors may furnish, at its option, engineers to supervise installation of equipment. This expense shall be born by the Purchaser. Purchaser accepts responsibility for all loss occurring during the erection of the equipment by events including, but not limited to, fire and natural disaster.

- 6. The Purchaser acknowledges and agrees that All Metro Electrical Distributors may utilize outside credit reporting services to obtain information on the Purchaser.

Any remedy of the Purchaser shall be with respect to any warranty extended by the Manufacturer. Returned Goods Policy

 - A. Merchandise being returned must be within 30 days of invoice date
 - B. All items returned must be stock material and of reasonable quantity
- C. All merchandise must be accompanied by documentation providing All Metro Electrical Distributors. with the following information: invoice number and date, product identification number, quantity of items being returned and reason for return.
 - D. Merchandise must be in reasonable condition as determined by a All Metro Electrical Distributors representative.

If all of the above requirements are met, the customer will not be liable for any restocking charge. If proper documentation as outlined in "C" above is not provided, then a restocking (Handling) charge may be charged to cover our additional expenses incurred in researching proof of purchase.
