Open Letter

After reading and listening to only a few experts, you can quickly understand that there are many issues with the PCR tests as a diagnostic tool, but more importantly, as a mechanism to justify lockdowns, measures, and restrictions to our rights and freedoms under the charter.

WHO Notice Excerpt: WHO reminds IVD users that disease prevalence alters the predictive value of test results; as disease prevalence decreases, the risk of false positive increases (2). This means that the probability that a person who has a positive result (SARS-CoV-2 detected) is truly infected with SARS-CoV-2 decreases as prevalence decreases, irrespective of the claimed specificity.

Most PCR assays are indicated as an aid for diagnosis, therefore, health care providers must consider any result in combination with timing of sampling, specimen type, assay specifics, clinical observations, patient history, confirmed status of any contacts, and epidemiological information.
