In the following contract, _____ will hereby be referred to as “buyer”, and certifies that the information provided above in the “Buyer Information” section is correct and current.

Additionally, “Breeder” and “Rosie’s Goldies” as referred to in contract are one and the same.

Details of this Limited AKC Registration Contract

This puppy is being purchased with the full understanding and agreement that this is a limited registration. The above stated dog is being purchased as a “Pet only” puppy. Buyer understands that it is their responsibility to prevent this dog from siring or whelping a litter while on “limited” registration. Buyer understands that it is the buyer’s responsibility to neuter or spay responsibly once the puppy has reached advisable spay/neuter age.

Right of Recovery:

Buyer understands that if, at any point they are unable to care for their dog **for any reason**, buyer must not surrender dog to a shelter or rescue, and **must** reach out to Rosie’s Goldies. Buyer understands that this dog may not, under any circumstances be given, sold or surrendered to any shelter, rescue, store, puppy mill, or broker; if dog is ever found to be in any shelter or rescue, Buyer understands that the Breeder retains the right to take possession of the dog, with all repossession rights including but not limited to AKC registration and the right to find a suitable home for the dog.

Puppy (72hr) Health Guarantee

Breeder verifies that all the above (“Puppy’s Information”) details regarding health check, worming and vaccination information is correct and complete. Buyer understands that Breeder has taken every precaution to produce a healthy puppy. If buyer has concerns regarding the puppy’s good health, buyer **MUST** 1) reach out to Rosie’s Goldies immediately with concerns, and 2) have puppy checked by a licensed veterinarian within 72 hours of ownership. If there is a problem specified by the licensed veterinarian that cannot be rectified, puppy may be returned to the Breeder at buyer’s expense (regarding travel etc.). Puppy must be returned within 24-48 hours of veterinarian exam, with a full and clear statement from certified veterinarian regarding the problem. Problem must be specific to puppy’s health and may not include environmental induced problems, including injury or accident that occurs after Buyer takes ownership of puppy. Rosie’s Goldies would offer a full refund if specifications above were met. All medical expenses are the sole responsibility of the buyer.

Health Guarantee (Dysplasia)

Rosie’s Goldies offers a 2 year Hip Guarantee against moderate or severe hip dysplasia, which would cripple a dog preventing them from proper movement.

Our health guarantee is only effectual under the following understanding and agreement:

- The dog must not be over or under fed.
- The dog must be fed high-quality dog food for the duration of the health guarantee.

- The dog must NOT have been spayed or neutered before the age of 18 months.
- The dog must not have whelped or sired any litters
- Buyer must willingly provide Breeder with veterinary's statement of dysplasia diagnoses, exam, and x-rays prior to dog being 26 months of age.

Buyer understands that should a puppy have health/gentic problems as specified above, Breeder would offer a puppy at half price, allowing buyer to retain original puppy if chosen. If buyer would like a full replacement puppy, they must return original puppy to the breeder. Breeder retains the right to evaluate the affected puppy at with their own veterinarian as a second opinion prior to any replacement pup being made.

Buyer's Cost of Care Responsibility

Buyer understands and agrees that Rosie's Goldies is in no way responsible for vet bills, cost of care or the death or injury of puppy/dog once the buyer takes ownership of the puppy. Breeder is in no way responsible for the loss of a puppy with illness due to the lack of vaccinations, accidental death (once buyer takes ownership), theft or any other loss beyond the Breeder's control, except as stated above in previous health guarantees.

I understand and agree to the terms of this contract. I acknowledge that this is a legal and binding contract, and that any breach of any portion of this contract would cause that portion of the contract to be null and void. This contract applies only to the original buyer and is not transferrable.
