## **PARKING**

## HOTEL ACCOMODATIONS

A minimum of five (5) double occupancy king-size hotel rooms is to be provided at the cost of the Purchaser for two (2) nights (Room and Tax Only). Hotel accommodations must be approved, in writing, by Artist Management.

- Reserved under individuals' names (room list will be sent by Artist Management)
- Non-Smoking
- Prepaid in full
- WiFi internet connections prepaid
- No credit card required from the Artist (Lock Out All Incidentals If Necessary)
- Hotel cannot be more than 30 minutes from the venue.

## DAY OF SHOW SCHEDULE

All times are dependent upon ticketed door and show times, please advise if they differ from the below sample schedule. Relative timings will remain the same even in the instance of different door or show times. Noise curfew (day or night), dark stage, union breaks, etc. must be communicated, in writing, in advance.

11:00 AM Access to building and dressing rooms + showers

**12:00 PM** Load in begins **4:00 PM** Soundcheck

5:00 PM Laser Focus

**5:00 PM** Dinner **7:00 PM** Doors

8:00 PM Floydian Trip performance

**10:30 PM** Load out

## **SECURITY**

The Purchaser is required to supply an adequate number of security personnel to prevent any danger to the audience, both inside and outside the venue. The Purchaser is required to provide adequate security to secure the stage, backstage, and dressing room areas before, during, and after the performance. Furthermore, the Purchaser is required to protect and secure all show personnel and their belongings, both owned by or leased for the performance, including but not limited to:

- Stage (left and right, bookend), wings, and equipment storage areas
- FOH Sound, Light, Video, and Laser positions
- Backstage and any band access areas including but not limited to dressing rooms, green room, production offices, and loading areas.

## LOCAL LABOR CALL

All venues will be addressed on an individual basis, but the following will be the benchmark for most shows...

## STAGING REQUIREMENTS

Two (2) risers (8'x8'x16") are also required to be provided at the cost of the Purchaser.

#### **OUTDOOR PERFORMANCES**

In the event of an outdoor performance, special considerations need to be made regarding the stage itself, rigging, wind panels, and our atmospherics. Four (4) additional foggers are required for outdoor performances at the cost of the Purchaser. Please contact Artist's Production Manager well in advance to discuss requirements.

## FRONT OF HOUSE MIX POSITIONS

Please provide an appropriate front-of-house mixing position. It should be a minimum of 12'W x 8'D. This space should be centered on the stage and no more than 75' from the downstage edge. This space should also have an unobstructed view of the entire performance area.

For more information on equipment, please see Audio Requirements, Laser Requirements, and Lighting Requirements sections.

## **POWER REQUIREMENTS**

A minimum of eight (8) 20amp non-GFI circuits to be provided onstage as per Artist Stage Plot. Please note that this power should be dedicated to the band's sole use and not part of in-house Audio or Lighting power requirements. Purchaser agrees to ensure that the proper grounding of electrical equipment and instruments is provided for.

## **AUDIO REQUIREMENTS**

Artist and/or Artist Representative shall have full input on both FOH Mix and Monitor Mix.

Purchaser is to provide a professional grade sound system for the venue capable of producing rock concert volumes and subsonic frequencies, preferably Adamson, L'Acoustics, Meyer, etc. Sound system shall be high quality, properly tuned, time aligned, fully maintained, and will cover the entire listening area of the performance, with an evenly distributed pattern (+/- 2db of mix position), capable of maintain a sustained average sound pressure level of 110 dbA from 30Hz-16kHz within the listening area.

Artist travels with a FOH console and IEM splitter rig. Stage micing and cabling will be done by Artist with tails being given to house snake for FOH. Artist carries 15' splitter tails. Any additional cabling necessary to get from Artist's IEM splitter to the house snake will be supplied by Purchaser at no cost to Artist.

Please allow the system to be driven with at least 3 lines from FOH. These lines should be House Left PA, House Right PA, and Subwoofers.

Control of all system parameters should be available to our audio crew from the beginning of load in through the end of the performance.

Please refer to attached input list / stage plot (pages 7 + 8) for more information.

## LASER REQUIREMENTS

BEFORE LOAD IN COMMENCES, IT IS VERY IMPORTANT THAT ALL VIDEO CAMERAS AND PROJECTORS WITHIN THE VENUE HAVE THEIR LENSES CAPPED AND COVERED UNTIL ARTIST'S LEAD LASER TECHNICIAN GIVES CLEARANCE. Dark Shadows Entertainment and Prism Entertainment/Floydian Trip will not be held responsible for damages due to failure to comply with this request.

Due to the nature of lasers, we require the performance space (stage/audience/anywhere that has a sightline to the stage) to be completely vacant except for Artist crew during laser/lighting focus. Please make it a point to put up signage on all doors leading into the performance space. If there is any issue, please discuss in advance with Artist's Production Manager.

## **ATMOSPHERICS**

Artist's performance uses theatrical haze/fog. Purchaser is responsible for confirming venue compliance with theatrical haze/fog, and if local laws dictate, a fire watch must be applied for and approved no less than 14 days before the performance. Purchaser is liable for any fees associated with these permits.

## LIGHTING REQUIREMENTS

Artist travels with a lighting designer and a full lighting rig. Artist will make use of your in-house system as well.

No follow spots are required.

## **BACKDROP + VIDEO REQUIREMENTS**

Tour travels with a 15'W x 12'H backdrop with appropriate flame certifications. This drop is to be hung upstage of the band, independent of the lighting systems.

In lieu of the backdrop, if the venue has an in-house projector and screen, Artist will supply a logo.

## **SOUNDCHECK**

Artist requires full access to the stage at least three (3) hours prior to Artist's scheduled performance. Artist will be allowed to soundcheck as a whole at full volume for at least one (1) hour. Soundcheck is to be completed prior to doors opening and at least one (1) hour prior to the performance start time.

#### CONSUMABLES

Please have the following equipment available for Artist upon arrival...

- Thirty-Six (36) AA alkaline batteries
- Four (4) AAA alkaline batteries
- Three (3) 9V alkaline batteries

Please have the following equipment available for Artist during load in...

- One (1) roll of quality black gaffer's tape (ProGaff, EIT, etc.)
- One (1) roll of quality brightly colored (vellow/pink/etc.) gaffer's tape (ProGaff, EIT, etc.)

All equipment listed above is to be provided at no cost to the Artist.

## MERCHANDISE/SETTLEMENT

Purchaser is to provide a minimum of 10'x10' space for Artist to sell merchandise. This space shall be in a prime location close to where the audience enters and exits the venue and will include one (1) eight-foot table with a clean tablecloth, two (2) folding chairs, and one (1) 15A circuit. Artist will provide an 8' tall merchandise display which will go behind the table.

No additional merchandising staff is required from the purchaser/venue.

# FLOYDIAN TRIP STAGE PLOT



#### GREEN ROOM / DRESSING ROOMS

Please provide a private, clean, climate controlled, lockable dressing room with power and WiFi available for the band's sole use. Dressing rooms should have comfortable couches, chairs, and tables available as well as the ability to accommodate up to twelve (12) people comfortably.

The band must have access to a clean working toilet, shower, towels, mirror, and sink with clean running water that is not accessible to the public. Bathroom should be stocked with toilet paper, paper towels, soap, and tissues.

Purchaser is to provide one (1) wardrobe rack able to accommodate twenty (20) hanging items of clothing without touching the floor/ground.

#### HOSPITALITY

Please make the following items available prior to the band's arrival...

- One (1) Dunkin *Box of Joe* fresh hot coffee with creamer, sugar, cups, lids, and stirrers.
- Twenty (20) bottles of cold bottled water (Poland Springs)
- Twenty (20) bottles of room temperature bottled water (Poland Springs)
- Twenty (20) bags of Traditional Medicinals Throat Coat Tea (Original w/ Slippery Elm)
- An assortment of chilled sodas (Sprite, Coke, Dr. Pepper, etc.)
- One (1) electric tea kettle
- Minimum of six (6) ceramic coffee mugs
- Minimum of twelve (12) place settings (NO PLASTIC CUTLERY!)

#### **CATERING**

Catering menu must be approved by Artist management at the time of the performance advance. If a meal cannot be provided, a cash buyout of \$55/person shall be provided and handed to Artist's representative at the beginning of load in.

**Breakfast:** NONE **Lunch:** NONE

**Dinner:** 10 people, including 1 gluten-free/dairy-free (serious gluten allergy!)

Time to be advanced, but no later than 2 hours prior to show time.
