2023-2024 Release of Liability/Waiver of Liability

I understand and acknowledge that activities conducted at or by Jam Hops Gymnastics Factory, Inc. (Jam Hops), which include but are not limited to gymnastics, tumbling, trampoline, dance, theater, and JH XSports imposes risks which could result in permanent injury, paralysis, death or damage to my child, myself, property, or third parties. Some of which may be caused by my own actions or inactions, or those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below. By the very nature of the activity, sports carry a risk for physical injury. No matter how careful the participant and instructor are, no matter how many spotters are used, no matter what the height is or what the landing surface is, the risk cannot be eliminated. The risk can be reduced, but never eliminated. The risk of injury includes minor injuries such as bruises or more serious injuries such as broken bones, dislocations (this is when a bone is pulled out of its socket) and muscle pulls. The risk also includes catastrophic injuries such as paralysis (this is when the injury prevents you from being able to use parts of your body) or even death from landing on your back, neck or head. I am also aware that participation in certain activities, including but not limited to day camps, involves transportation to and from field trips and such transportation could cause injury or death in a vehicular accident. Being fully aware of these dangers, I hereby consent for my child(ren) and/or myself to participate in any and all Jam Hops programs and activities and I ACCEPT ALL RISKS associated with such participation. I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the Activity. I hereby release, discharge, and covenant not to sue Jam Hops, its respective administrators, directors, agents, officers, volunteers, employees, other participants, sponsors, advertisers and, if applicable, owners and lessors of premises on which the Activity takes place (each considered one of the RELEASEES herein), from all liability, claims, demands, losses, or damages on my account caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which may incur as the result of such claim. 2023-2024 Class Withdrawal Policy

If you would like to cancel participation in a class or program, written notice must be received by the last business day of the current month to cancel billing for the following month. Withdrawal notices received after the first business day of the month will not receive a refund. Jam Hops may choose to drop a participant from class if there is an outstanding account balance. You can find our unenrollment form on our website at www.jamhops.com. Exceptions to this policy may be made and communicated for classes and programs that are offered and run on a session basis.

Attendance Policy: Any participant who is absent from classes for 8 consecutive weeks without any contact or communication with Jam Hops will be dropped from their classes. Jam Hops will maintain a system to monitor participant attendance on a weekly basis. This system will track attendance and identify participants who have been absent for 8 consecutive weeks. Notification will be sent once a participant has been absent for 2 weeks and will continue weekly until 8 weeks though email and phone calls.

The objective of this policy is to ensure the effective management and attendance of participants in classes. By implementing this policy, we aim to maintain a supportive and accountable learning environment that promotes participants' success, while also providing an opportunity for participants to address any extenuating circumstances that may prevent them from attending classes.
