ORDER

IT IS HEREBY ORDERED, ADJUDGED, DECREED AND AFFIRMED that:

1. Respondent shall immediately **CEASE AND DESIST** from any further property management activity that constitutes the unlicensed practice of real estate under Ind. Code § 25-34.1-3-2.

2. Respondent shall be punished for contempt of court in either circuit or superior court should Respondent violate the terms of this order to cease and desist the unlicensed practice of real estate.

This Administrative Law Judge Panel's Order is not the final order of the Commission in this proceeding. However, in the absence of any objection, the Commission either will affirm the Administrative Law Judge Panel's Order as its final order or will serve notice of its intent to review any issue related to the Administrative Law Judge Panel's Order.

- 5. Respondent's activities include, but are not limited to, offering real property for lease, entering into property management contract(s) with owners of real property, and collecting rent and fees due on real estate owned by others.
- 6. At no point does Respondent own the real property for which it provides the services described in paragraph 5.
- 7. On or about January 12, 2009, Respondent entered into a contract with Zeb and Abdul Manjee ("the Manjees"), employing Respondent "to rent, lease and manage" real property owned by the Manjees.
- 8. The contract granted Respondent "full management and control" of the real property, including the ability to prepare and negotiate leases and the ability to pursue eviction proceedings in the Manjees' name.
- 9. Respondent advertised its property management services on a page at www.facebook.com.

- 10. Respondent's Facebook page stated, in part, "[W]e are prepared to assist you in all aspects of the management of your investment," and, "We provide a viable alternative to selling your home by complete management services designed to provide you with a great experience and income."
- 11. Respondent has taken steps to become licensed under Ind. Code art. 25-34 but has not yet fully complied with statutory licensing requirements.
- 12. Respondent did not intend to evade the law; rather, Respondent was unaware of the statutory licensing requirement.

CONCLUSIONS OF LAW

- 1. Pursuant to Ind. Code § 25-1-7-14, the Commission has the authority to issue an order for Respondent to cease and desist the unlicensed practice of real estate.
- 2. Respondent's property management activity as described above constitutes a violation of Ind. Code § 25-34.1-3-2, which prohibits any person from acting in the capacity of a real estate licensee without first obtaining the necessary license.

ORDER

MOTION FOR ORDER TO CEASE AND DESIST

The State of Indiana, by Deputy Attorney General Lisa S. Wolf, pursuant to Ind. Code § 25-1-7-14, files this motion requesting the Indiana Real Estate Commission ("Commission") to order Property Management Services of South Bend, LLC ("Respondent") to Cease and Desist the practice of real estate without the required license. In support of this motion, the Office of the Attorney General ("Petitioner") alleges and states as follows:

- 1. Petitioner is empowered to bring complaints before the Commission in the name of the State of Indiana pursuant to Ind. Code § 25-1-7-2.
- 2. The Commission is charged with the responsibility of regulating the practice of real estate in the State of Indiana pursuant to Ind. Code § 25-34.1-2-5.
- 3. Respondent's mailing address is 2043 South Bend Avenue #124, South Bend, Indiana 46637.
- 4. Respondent also operates under the name "Property Management Services of South Bend Indiana, LLC."

- 5. Respondent does not currently employ, nor has Respondent ever employed, an individual holding a professional license issued under Ind. Code art. 25-34, Real Estate Brokers and Salespersons.
- 6. Pursuant to Ind. Code § 25-34.1-3-2, "no person shall, for consideration, sell, buy, trade, exchange, option, lease, rent, manage, list, or appraise real estate or negotiate or offer to perform any of those acts in Indiana or with respect to real estate situated in Indiana, without a license."
- 7. Respondent has engaged in and continues to engage in activities for which a license is required under Ind. Code § 25-34.1-3-2. Respondent's activities include, but are not limited to, offering real property for lease, entering into property management contract(s) with owners of real property, and collecting rent and fees due on real estate owned by others.
- 8. At no point does Respondent own the real properties for which it provides the services described in paragraph 7.
- 9. On or about January 12, 2009, Respondent entered into a contract with Zeb and Abdul Manjee ("the Manjees"), employing Respondent "to rent, lease and manage" real property owned by the Manjees. (A true and correct copy of Respondent's contract is attached and incorporated herein as State's Exhibit 1.)
- 10. The contract granted Respondent "full management and control" of the real property, including the ability to prepare and negotiate leases and the ability to pursue eviction proceedings in the Manjees' name.
- 11. Under the contract, Respondent was entitled to a \$125 "initial management fee" and ten (10) percent of rent collected.

12. Respondent advertises its property management services on a page at www.facebook.com. (A true and correct copy of Respondent's Facebook page is attached and

incorporated herein as State's Exhibit 2.)

13. Respondent's Facebook page states, in part, "[W]e are prepared to assist you in all

aspects of the management of your investment," and, "We provide a viable alternative to selling

your home by complete management services designed to provide you with a great experience

and income."

14. By engaging in activities for which a license is required under Ind. Code § 25-

34.1-3-2, Respondent is subject to a show cause hearing and the issuance of a cease and desist

order pursuant to Ind. Code § 25-1-7-14, which states that the Commission may issue an order

requiring the Respondent to show cause why the Respondent should not be ordered to cease and

desist from activities for which a license, certification, or registration is required.

WHEREFORE, Petitioner respectfully requests an order against Respondent that:

1. Directs Respondent to immediately cease and desist any activity that is considered

the practice of real estate pursuant to Ind. Code § 25-34.1-3-2 without the

appropriate license; and

2 Provide any other relief that the Commission deems just and proper.
