

## Seasonal Contract Agreement (WATER/ELECTRIC)

I/we agree that we have read and agree to all of the terms and rules and regulations of Bluebird Family Camp LLC. ( a copy of said agreement terms / rules is available on the business website at bluebirdcampground.com A copy of the agreement is readily available to view and read on site at the Rec Hall.)

**Fees.** The Camper will Pay the following fees: All fees are **non-refundable**. A late fee of the greater of \$10 or 5% will be added to payments made after the due date. Late payment interest is 1.5% per month. Camper shall pay a seasonal fee in the sum of **\$2700 (Plus sales tax of \$148.50 for a total of \$2848.50)** for a water/electric site. Said seasonal fee is due and payable in full upon execution of this Agreement.

### Deposit for following year:

The Camper agrees to sign the agreement indicating they are staying for the following year and pay a nonrefundable Security deposit of \$500.00 by October 15th, 2022 to secure their site. The balance of your site fee is due by April 1, 2023. If you choose to use a credit card you will be assessed an additional \$100.00. Any relocation of your site for 2023 is subject to a \$200.00 relocation charge.

*If you do not plan to return for our 2023 season, we require that you have your camper removed from the grounds by November 1st, 2022. In the event that your camper is not removed by November 1st, we will seek to recover any and all costs associated with the removal and storage of your camper as per our current seasonal contract (p.8, ¶2)*
