Training Contract

Outlined below are the standard terms applicable to this agreement.

Client agrees to vaccinate or have vaccinated their dog for the following canine diseases before placement in Southern Tide Kennels' training program. Proof of fulfillment for the vaccination requirement via veterinary documentation is mandatory to this agreement.

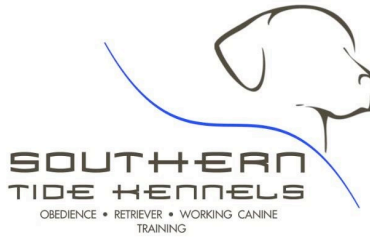
DHLP/ P/ B and Rabies.

Client agrees to provide or to pay for the administration of monthly heartworm, flea, and tick prevention.

Client agrees to cover any and all expenses related to emergency and/or routine veterinary visits required for client's dog while under the care of Southern Tide Kennels.

Client understands that while Southern Tide Kennels takes all necessary precautions to ensure optimum health and safety of all dogs in training, the rigors and terrain dogs encounter are unpredictable at times. The client agrees to hold Southern Tide Kennels (and/or any affiliates) harmless for any injury, sickness, and/or death.

Training fees are billed once per month via email on the 20th of each month and are due on the 1st of every month. Rates are subject to change. Bills not paid by the 10th will result in the dog (s) going on boarding ONLY status and will not be trained until the bill is paid.

Client understands and agrees that training fees are on a “per month” basis and will not be pro-rated if the client decides to take the dog home for any reason other than medical before the end of the billing cycle.

Client agrees to pay the credit card fees that are applied to the bill, if bill is paid with a credit card. Credit card fees can be avoided by mailing a check or paying with cash.

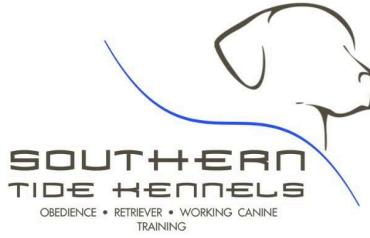
Client understands that the training timelines are approximate and are completely based on the dog’s inherited abilities (health, intelligence, drive/desire, temperament, early socialization, etc.). Therefore Southern Tide Kennels recommends purchasing a well-bred puppy/dog prior to enrolling into our program.

Retriever Training Program is a minimum of 3 months
