Council for Social Devleopment, Southern Regional Centre, Hyderabad has published significant work and organized several academic events in the year 2017-2018. The Telangana Social Development Report 2017 was launched this year in May 2017 by the Hon'ble Finance Minister, Sri Eatala Rajender in MCRHRDIT. Apart from the annual workshops on research methodologies, this year also featured a workshop on advanced writing, a dire need of young research scholars that CSD-SRC hopes to address on an ongoing basis. Finally, two of the five PhD candidates registered in CSD through TISS Mumbai and TISS Hyderabad – both ICSSR doctoral scholars -- were awarded their degrees at convocations held in May 2017.

The support of ICSSR, the Government of Telangana and the Reserve Bank of India deserves special mention. We look forward to their renewed support in the years ahead. CSD Southern Regional Centre thanks all its donor partners, scholars and public persons who have delivered public lectures, participants in our seminars and workshops and well-wishers who have enriched the quality of debate in social sciences and constantly encouraged us to do more.

### Study and Documentation of Deaths in Sewage & Septic Tanks

In growing Indian urbanization, the deaths of persons entering sewage and septic tanks is a stark reminder of the distance we need to travel yet. This study highlights the violations of Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013 and details the vulnerabilities of women and children who suffered the loss of immediate family members.

The study documents a sample of sewer and septic tank deaths in 3 states namely Telangana, Tamil Nadu and Delhi-Haryana; records socio-economic educational situation of survivors; documents structural defaults in the system which resulted deaths in sewer lines; traces the implementation of the judgment of the Supreme Court; points to hurdles in receiving compensation; documents official version of deaths and delay in delivery of compensation; explores the reach of other rehabilitation schemes to dependents; and attempts an understanding of the situation and hardship of single women in this context.

The research involved visiting the families of the deceased; collecting all the information about the accident by interaction with family members; interactions with community around deceased family, relatives etc.; collecting all the documents related with the death like photographs, death certificate, post mortem report, identity card, voter ID, proof of employment and tenure (temporary, contract or permanent); list of dependents, information on indebtedness, details of property and assets; status of compensation and response of authorities after the accident.

The following broad recommendations are based on the findings of the study, which pointed to gross negligence on the part of appropriate authorities and a non-compliance to the directives of the Supreme Court:

- 1. No person should be allowed to enter inside sewer and septic lines.
- Cases of criminal negligence should be filed against the responsible officers in the event of persons being allowed to enter sewers and septic lines putting their lives in danger.
- Work contracts should be scrutinized and comply with the norms of decent work and wages. Strict implementation of Supreme Court Judgment should be ensured.
- 4. Compensation, in the event of death, must be enhanced and expedited without increasing the suffering of families. Political pressure and civil society momentum should be built to stop these deaths.

### 2. Dalit Drum Beaters in Odisha: Changes and Continuity since Early 20<sup>th</sup> Century

The Dalit drum beaters' community has historically earning their livelihood by performing on social occasions. There have been some discernible shifts after the introduction of technology in music, which has effects on livelihoods of performers. 'Ganda baja' is a major source of livelihood in major part of western Odisha providing sustenance for at least six months annually to families involved in this cultural form.

This study attempted to write a history of the dalit drum beaters since 20th century mapping changes and continuities, and mapping changes in livelihood pattern of Dalit drum beaters over time – what have been the specific changes in performance livelihoods rooted in the caste structure; it also investigated the role of regulatory mechanisms at the community level to safeguard performance based livelihoods to ensure sustainability and survival.

The study was carried out in 10 districts of Odisha – Sundargarh, Jharsuguda, Sambalpur, Deogarh, Boudh, Subarnapur, Bolangir, Kalahandi, Nuapada and Bargarh -- where it is the 'Ganda'/'Pan Community' who earn their livelihoods by working as drum beaters. After a listing of all the villages where this community resides, the entire population of the community in such villages was included in the sample for purposes of a detailed survey. Long interviews were conducted with fifty groups of Ganda baja parties. Apart from this the five main actors namely (i) Muhuria; (ii) Dhulia; (iii) Tasia; (iv)

Nisnia; and (v) Jhumkia were also interviewed individually. The communities responsible for allied tasks like preparing the skin cover of the Dhol, the carpenters who construct the wood structure of the instrument, the Ganda people involved in Danda dance, among others were consulted for the data collection. The study adopted a multi-pronged approach for collection of information: (a) oral history from different actors; (b) information from old films and documentary films; (c) novels; (d) in-depth research into secondary sources (published and unpublished); and (e) primary field survey with different levels of actors including importantly practising drum beaters.

Despite their skill, proficiency and recognition from other states, the institutional mechanisms to ensure the well-being of these communities is poor in the state of Odisha despite a stronger law and policy framework in the postindependence era. Further rapid technological change and changes in the tastes for performance have posed serious challenges to the survival with dignity of these communities. is need to revisit state policy, skill sets, socioreligious constraints and most importantly, how may the vulnerabilities of this community be mapped onto the vulnerabilities of Dalit livelihoods generally? What are the continuities and discontinuities between these and other similarly placed communities? How do Dalit Drum Beaters reproduce and/or rupture caste lines?

### 3. Cultural Disparities among the Tribes in India: Exploring through Oral Literature

Tribal oral literatures in India area repository of culture, collective memory and indigenous knowledge systems transmitted in ways that strengthen social cohesion and bonding. This study attempted to sketch a portrait of tribal literary cultures and its relation to tribal societies. The primary questions that emanated from the study pertained to the relation of the songs with community identity and production; understanding the society through songs; the relative status and disparities among various

forms of tribal orality; the relationship between material well-being and tribal oral traditions; the demographic profile of tribes with strong oral traditions; and institutional/state mechanisms for the preservation and dissemination of oral traditions. The study, essentially an archival exercise of documenting traditions and practitioners' experiences involved the extensive collection of songs, recording, transliterating and translating the songs into Hindi.

### 4. Land Markets, Rising Agricultural Land Prices and Implications for Agricultural and Allied Productive Activities: A Comparative Study of Andhra Pradesh and Maharashtra

This study attempts contemporary a understanding during late reforms period (since 2001) on the nature of market for the agricultural land sales, higher prices and their factors and implications in two different markets for agricultural land in India – the free market in Andhra Pradesh and the restricted market in Maharashtra. The study is based on both secondary and primary data collected from a field survey in six selected villages from three districts at different levels of agricultural development in each state.

Significant proportion of agricultural land is being transacted in the sale market in both Andhra Pradesh and Maharashtra. The land is increasingly sold by the small size cultivators and it is being increasingly bought by the rich non-cultivators for non-productive purposes like store of value for surplus money, speculative

motive and tax benefits. Within cultivators, only medium and large farmers are able to buy the land. The purchased land is developed less and either it is leased out or kept fallow.

The continuation of the above trends in the agricultural land sale market will have adverse impact on the equity and efficiency in the agricultural sector where the ownership of agricultural land is being slowly taken away from the hands of the cultivators and will increase the tenancy which has many other problems especially when it is informal. The solution lies not in framing just one stringent law and implementing it forcefully, but ameliorating the distressed conditions in agricultural sector by ensuring decent income and livelihoods to the small size cultivators so that at least they will not be distressed or tempted to sell off agricultural land.

### 5. Socio-economic Profile of Fishing Communities in the State of Telangana

Telangana State is endowed with vast resources in terms of rivers, canals, reservoirs, lakes, ponds, tanks and other water bodies having immense scope for development of inland fisheries to improve food security, provide employment opportunities to improve the socio-economic status of fishers and other people engaged in the sector. Fishery is one of the fast growing sectors contributing to GSDP of the Telangana State as well as generating income and employment. Fisheries sector contributes 3.47 percent of GSDP from agriculture and 0.6 percent to the GSDP during 2014-15 at current prices. The state of Telangana ranks third in availability of water resources but in case of fish production it stood 8th. The State has a rich water spread resource base includes 80 reservoirs spreading about 1.86 lakh hectares, and 28,822 tanks with Water Spread Area (WSA) of 4.02 lakh hectares and 474 ponds having water spread area of 781 ha and also 1808 kms of rivers and canals flowing in the state.

This study strongly weighted towards quantitative and qualitative inquiry aims at a comprehensive understanding of this sector in the state of Telangana. The present study was taken up by the Council for Social Development, Hyderabad with the following objectives: (1) To study the present status and prospects of inland fisheries in Telangana state; mapping of communities engaged in fishing at various points in the chain (a) as sole livelihood, (b) as main livelihood, (c) as subsidiary livelihood, (d) as traditional regular occupation (even if supplement), (e) as a casual involvement; and (2) to know the comparative socio economic conditions of fishers of different water resources.

Through a multistage sampling method a total of 12 villages were selected for detailed study, which commenced with a house-listing to identify fisher households. Out of total households enumerated (4181), 779 households reported that their main livelihood is fishing and fishery related activities. A total of 316 fishing households were selected purposively evenly spread across the districts.

Among the tank fishing households 93 percent belong to OBC. The problems faced had largely to do with inadequate water resources to meet their fishing needs, a paucity which they attributed to (i) encroachment of tanks by the villagers; (ii) common pool resources and competition in use of water; (iii) low availability of water levels in summer; (iv) drought. Over half the sample households knew of Mission Kakatiya. Forty six percent of fishers in the sample households are landless and for most of them fishing is their main occupation. Among those who own land, most of them own below a hectare of land. Irrespective of fishing category, 48 percent of total fishers are illiterate and among the literate, most of them studied up to upper primary only.

While the fishery sector needs to be strengthened in the state, the strengthening of fishing communities through cooperatives, creation of equitable marketing networks, transportation facilities, promotion of education and creation of individual and communal assets and innovative policy will go a long way in the rapid development and equitable growth of this sector.

### 1. Performance of Pradhan Manthri Jan Dhan Yojana in Telangana

Financial Inclusion is a multi-dimensional concept. One cannot dream of inclusive growth in a monetised economy with imperfections in product market, labour market and financial and credit market. Both Government of India and Reserve Bank of India are taking various measures to promote financial inclusion in the country. For instance, in 2009 Government of India made it mandatory for the payment of wages to the wage-seekers under MGNREGS through either bank or post office. In promotion of financial inclusion, Government of India launched 'Pradhan Manthri Jan Dhan Yojana (PMJDY)' a national-level scheme in 2014. The Scheme envisages universal access to banking facilities with at least one basic banking account for every household. The present project makes an attempt to study the impact of PMJDY on Financial Inclusion in Telangana State.

The objectives of the study are to explore the causes for financial exclusion of rural households; study the impact of PMJDY Accounts on rural households; and find out the



problems encountered in operating the account.

It is proposed to use multi-stage sampling design. At first stage two districts one better performing and another moderately performing, will be selected for the study in the Telangana State. At second stage Two Mandals from each district will be purposively selected where the Jan Dhan Accounts have been opened, making a total of four Mandals. Further one village from each Mandal, thus a making a sample of four villages, will be selected for canvassing of the structured questionnaire, both households including exclusively holding Jan Dhan Accounts and households holding Saving and Jan Dhan Accounts.

It is expected to complete the primary data collection by the end of July 2018.



### 2. Geographical Indication Protected Agricultural Products from Select States of India: An Inquiry into the Economic, Livelihood and Institutional Aspects

(In collaboration with Gujarat Institute of Development Research, Ahmedabad)

Geographical Indication (GI) is one of the intellectual property rights (IPR) tools. GIs are defined as products that are associated with a region. These products have special quality or characteristics or reputation based upon the climatic, physical or production characteristics unique to the region.

With respect to agricultural registered GIs in India, this study seeks to examine the following: (1) the strategies adopted by the registered proprietors of GI to realize economic returns from the registered product, (2) the role and functioning of the FPOs, (3) to measure the attributable impact of GI protection on the producers and (4) to understand the socio, cultural, economic, and institutional spillover outcomes of GI protection on variety of stakeholders. The study is being undertaken in the states of Maharashtra, Kerala, Gujarat and Andhra Pradesh.

The reason for selecting the four states are as follows: Maharashtra has a variety of products filed by the farmer producer organisations.

This gives us an opportunity to understand the effective functioning of the FPOs and the impact of use of GIs on the reference products. Kerala is chosen because of the fact the different GIs are owned by FPOs and Kerala agricultural universities. Gujarat and Andhra Pradesh have so far filed only 3 agricultural GIs, though there are a number of potential candidates. Hence, the learning from the case of Maharashtra and Kerala would be helpful for Gujarat and Andhra Pradesh.

The review of literature and instrument tools for data collection has been finalized. The Advisory Committee of the study was conducted in March 2018 and the field work is in progress in Gujarat (Bhalia Wheat and Gir Kesar Mango), while in Kerala and Maharashtra it will commence in May-June. In Andhra Pradesh, it was found that the variety of GI which was filed for registration of Guntur Sannam Chilli is no longer cultivated and the derivatives from the variety is now widely cultivated and sold.

### 3. Electoral Politics and Elected Presidents of Dalits and Adivasis: A Study of Gram Panchayats in Telangana

In the context of 73rd Amendment Act, this study attempts to understand the political dynamics of elected presidents belonging to Scheduled Castes (Dalits) Scheduled Tribes (Adivasis), their electoral politics, institutional decision-making and their place in the rural political system. What factors influenced them to contest for election as President of Gram Panchayat? How are they exercising their power in specific political contexts in which they are located? The objective of this research is to explore the performance, challenges and issues of elected local leaders in the functioning of gram panchayats and grassroots politics in exercising the institutional power and the development of village.

The study focuses on the (old) districts of Adilabad and Nizamabad of Telangana State; and West Godavari and Prakasam of Andhra Pradesh. The pilot study has been completed and main phase of field work is scheduled to commence in July 2018.

### 4. A Study of Quality and Effective Utilisation of Digital Lessons in Telangana

The Government of Telangana, with the aim of improving educational quality through the use of ICT, has provided digital equipment for all the high schools to use either online or offline or both depending on the availability of digital infrastructure.

The Government has prescribed a time table for on-line digital classes for the high schools in the state. Accordingly, online digital lessons have been relayed for all the students of V to IX class through Mana TV from the academic year 2016-2017. Apart from this, soft copies of the digital lessons were also provided for offline usage by the schools depending on the available of digital infrastructure in schools.

The present study attempts to assess whether teaching with digital aids is accessible to students according to the time-table given by the state at school level; whether the digital equipment (online and offline) is adequate for the use of students in the schools; whether the teachers are capable of operating digital lessons to the students.

The study is mainly based on primary data collected from the schools – the participants in the study are students, teachers, Mandal and district level officials implementing the scheme of digital classes. The study has been taken up in 10 sample districts out of 31 districts in a manner that represents each of the old ten districts of the state. From each district, two mandals were

selected – one district headquarters and the second an interior mandal. From each mandal 4 to 5 schools were selected purposively where the student strength is relatively high and low giving representation to Telugu and English medium. In each district, representation was also given to 1 Model school, 1 Residential school and 1 KGBV school in the sample. In all, the primary data was collected from 92 schools.

The preliminary findings of the study indicate that the online programme of Mana TV lessons were not viewed by students in majority of the schools from October 2017. The main reason for non-usage of digital lessons was ROT problem in most of the schools where the ROTs have been disturbed due to attacks on them by monkeys. The other reason cited is that the teachers are busy with 3 R's programme of the government which is a priority. The average number of digital classes viewed for each subject by the students was less than 10

for the entire year and it is nil or very limited in some of the sample schools. The students of English medium expressed that they have not viewed any digital lessons for lack of either digital equipment or separate room for offline digital classes.

The common feature as observed in schools was that the online and offline digital equipment was kept in one single room in most of the schools, which means the students have to forego one facility. Hence, English and Telugu medium students have viewed on Telugu lessons. There were other problems like floor seating, multipurpose deployment of digital classroom, and inadequacy of trained and computer literate teachers, to name a few. The study found that the students in all the schools expressed the desire for digital classes especially in science and geography.

# 5. Strengthening of Schooling for Chenchu Children: A Study of Ashram Schools in Nagarkurnool District of Telangana State

This study aims at understanding the barriers to formal schooling faced by Chenchu children in Nallamalla, through detailed interviews, participant observation and ethnographic field work in select schools and in the villages the children come from. Give the high dropout and non-enrollment of Chenchu children as also the very low capacity of schools to retain them in school, the study attempts a deep understanding of the place of schooling in the Chenchu community.

The field work is scheduled across two academic years – 2017-18 and 2018-19, and research participants include students, former students, and teacher, supporting staff of hostel, school principals and others identified with the school and in the Chenchu community during the two academic years. It is proposed to conduct around 50 long interviews over multiple sittings with children enrolled in schools as well as children who have dropped out recently.

# 6. Challenges and Prospects of Multi Lingual Education: An Ethnographic Study of Students from the Urdu Speech Community in the City of Hyderabad

Multilingual education or MLE, in the simplest of definitions, refers to the use of two or more languages as the medium of instructions in schools where these languages are used to teach content matter of subjects rather than the languages as such. MLE is also seen by many as the panacea for the ills of the linguistic imperialism of English and other dominant languages over the indigenous and tribal minority (ITM) languages. The goal of MLE is to address these significantly crucial issues of language loss, shift, subtractive bilingualism, and cultural loss. MLE refers to the learning of both Urdu/L1/MT and English/L2/Official language so that individuals are equipped enough to function in domain appropriate language(s).

The present study, against this background, attempts to understand the various issues and challenges faced by the students studying in monolingual (Urdu and English medium schools) of the Urdu speech community in Hyderabad. Concomitantly, it tries to find out the extent to which Mother Tongue based MLE (here, Urdu) could help improve students' overall academic performance.

The study also tries to examine how the unique politico-social history of Urdu language vis a vis other Modern Indian Languages impacts the students' bi/multilingual skills in L1/Urdu and in L2/English. It further tries to understand the extent to which these students associate themselves with Urdu as a significant marker of their identity in the face of globalization (where English is the dominant language of communication).

It is only through an ethnographic study that we may understand the complexities of language situation - linguistic issues and education - among Urdu speakers. Long interviews, observations, and content analysis are being employed in this study; a questionnaire was also used to cull descriptive data only on students' socio-linguistic profiles. Auto-ethnography, in this study, is being used as a tool to anchor personal accounts in the larger socio-cultural contexts.

### 7. Deep Sea Fishing and Small-Scale Fishers: Focus on Economics of Tuna Fishing Crafts in Andhra Pradesh

Under the Blue Revolution programme of the government of India aimed at increasing fish production and protecting the interests of small fishers, deep sea fishing in marine sector is one scheme that is aimed at increasing fish production by reducing the pressure on near shore fishing and harnessing unexploited and underexploited fishery resources by targeting the tuna and tuna like fishes, from deep waters that have remained out of reach of traditional fishers.

The sub-component aims to introduce intermediate size of modern deep sea fishing vessels (DSFVs) to the traditional fishermen for operating in the Indian Exclusive Economic Zone (EEZ), beyond territorial waters. The government of India has formulated schemes to supply certain accessories to small scale fishers like mechanized and motorized boats and promoting target specific gear like long line fishing to tap un-tapped potential fishery resources like Tuna, through deep sea fishing.

Against this background, the present study aims to study this initiative in Andhra Pradesh.

The objectives of the study are (1) to evaluate the problems of small scale fishers in getting the crafts under deep sea fishing scheme for converting and construction of new crafts for catching the Tuna fishes; (2) to study the technoeconomic and operational characteristics of different categories of tuna fishing crafts and gears and find out the investment sources to acquire the craft and gears; (3) to work out the investment, operational expenditure, variety wise quantity, value of Tuna catch and net profit that has accrued to different varieties of crafts; (4) to know how far the fishing communities have used remote sensing techniques to locate the Tuna and problems facing in their fishery operations; and (5) to examine the comparative socio-economic conditions of different craft owners who operate and catching tuna;

Different types of Tuna fishing craft owner households in marine villages of Andhra Pradesh are the universe of the study. The proposed study will be taken up in three coastal districts of Andhra Pradesh. Multi stage stratified sampling procedure will be adopted for this study.

### 2. One-day Brainstorming Session on 'Financial Inclusion through PMJDY'

The brainstorming session was inaugurated by Sri. R. Subramanian, Regional Director, RBI and officials from various banks participated in the discussion. The main objective of the discussion was to provide a common platform for policy regulators, policy implementers, researchers and scholars to have a better understanding on the various issues concerning the subject. The findings of a pilot study of two villages on the Performance of PMJDY were shared among the participants and felt that the outcome of the discussion would provide useful inputs to the ongoing project on PMJDY in Telangana at Council for Social Development, Hyderabad.

The Regional Director, Reserve Bank of India, Hyderabad identified few questions which would be of interest to be taken up in a detailed study:

- What is the impact of Demonetisation on Account-holders of PMJDY?
- What is the progress with respect to distribution of Rupay Debit Card to the Account-holder? Has it increased the number of cashless transactions? Is it being used only for withdrawing cash? What is the extent of the awareness among the entrepreneurs?
- What is the number of operations made by the Account-holders during the Demonetisation period and other periods?
- What is the experience of the customers with respect to compensation received due to unfortunate incidence like death and accidents?
- How far did migrant labour benefit from PMJDY? Is it reaching the migrant workers? Is migrant worker making use of the scheme for remitting the amount to the family at his native village?
- What is the impact of cut in interest rate?

- What is the message sent to the Account-holders by the Bank? Are the Banks interested in inviting the customers or want to drive them informal sector? Is it not a regressive step to pay higher interest rate for large depositors?
- What is the cost borne Bank in maintaining Zero Balance Accounts? Who should bear the burden of incentive amount? Who should bear the cost incurred due to high attrition rate among BCs?
- What is the overall impact of whole linkage of PMJDY, Aadhar, Mobile Banking and DBT?
- What are the new products tailors made to farmers of Telangana and catered to the local issues?
- What is the impact of PMJDY on the business of Money-lender Chit fundagents?

### 3. Ten-Day Capacity Building Workshop on Quantitative Techniques in Research

To improve the quality of research in Social Sciences a Ten-Day Workshop on Quantitative Techniques in Research was organised by Council for Social Development, Hyderabad during December 04 - 14, 2017 for Faculty Members and Research Scholars in Social Sciences. At the time of selection of candidates, priority was given to scholars who had recently registered for PhD. In all, twenty-six Faculty Members and PhD Scholars from different Universities and Colleges within the State like Osmania University, Hyderabad; University of Hyderabad, Hyderabad; and outside the State like Karnataka University, Dharwad, Karnataka; Kuvempu University, Shimoga; VSKU, Bellary; Central University of Tamil Nadu, Thiruvarur; Sacred Heart College, Cochin; St. Philomena College, Puttur and Madras School of Economics, Chennai; etc. participated in the workshop. The participants were largely from Economics, Commerce and Management.

### 4. Five-Day Orientation Programme on Research Proposal Preparation and Writing Skills

Five day orientation programme on proposal preparation and advanced writing skills for research was organized for research scholars and faculty of Social Sciences during 20 -24 December, 2017. The orientation included lectures, group discussions, and guidance for publication of research. The programme was inaugurated by Prof. M. Gopinath Reddy, CESS, Hyderabad. There were 22 participants from all the disciplines of social sciences from all over the country. The orientation programme ended with presentation of research papers/ proposal of their Ph.D. work by the participants.



# 5. Workshop on Qualitative Research Methods and Advanced Writing for Doctoral Scholars in Social Sciences and Humanities

The Workshop on Advanced Writing was an intensive 10 day programme that drew in 17 scholars from different states: Tamil Nadu, Telangana, Andhra Pradesh, Punjab, Uttar Pradesh, New Delhi and Maharashtra from state and central universities. There were 3 women scholars in the group. In terms of discipline, participants were from Media Studies, International Relations, Women's Studies, Sociology, Development Studies, Economics, Political Science, Business Management and Beginning with a documentary film by noted film maker Deepa Dhanraj on the students' movement that spread across universities after the death of Rohith Vemula, the workshop discussed the different uses of research and the different ways in which research findings could be presented - film being one powerful medium. The themes emerging from the film had a direct bearing on social science research: untouchability, vulnerability, barriers to education, caste discrimination, affirmative action and reservations, and the archives of the social sciences - notably the writings of anticaste philosophers and constitution makers like Dr. BR Ambedkar. The first day focused on a detailed discussion of these themes and related readings. The workshop was built around the

work that individual scholars were engaged in - with discussions focused around the research notes they submitted that explored their current work. The library and archival holdings of CSD were opened out for workshop participants to research their areas of interest in some depth and present the note for comments and discussion. Review of literature, the delineation of a conceptual field, building a theoretical framework and presenting supporting materials from the field, ethics in social science research were some of the issues directly relevant to the participants' experience in research. This was part of the larger discussion on writing research papers that drew on fieldwork. In approaching the field, the importance of qualitative methods with a special focus on long interviews was underscored. The workshop included detailed practical sessions on writing research proposals and an introduction to writing book reviews.

The workshop on qualitative methods and advanced writing followed a flexible and discussion-based format that required scholars to complete short writing and reading assignments for discussion and review in the duration of the programme.



An international conference on the fate of egalitarian programmes drew participation from across the country as well as senior scholars from Germany and Brazil in an event co-organised by ICAS-MP and CSD, Hyderabad. While we also had several book discussions, the volume of essays on feminist research methodologies was launched by Dr. Maithreyi Krishna Raj, a pioneer in women's studies at Bangalore University, followed by a felicitation of Dr. Krishna Raj.

Egalitarian political programmes have taken rather similar trajectories in India and in Brazil: They became politically influential during protests against a social structure that is based on systems of fine-grained hierarchical categorizations. These protests resulted in formal and informal political programmes aimed at eliminating these categories or at mitigating their effects; at the beginning, this programmes were supported by a relevant part of what is often (misleadingly) called the middle class. The success of these programmes, while real, has been rather limited; even those egalitarian norms that have been formally institutionalized (e.g. through laws) have only a tenuous influence on the operations of public bureaucracies and even less influence on informal everyday practice. Moreover, there are countermobilizations by middle class and upper-middle class groups that demand recognition for their (allegedly) higher status and develop new, modernized justifications for existing inequalities (e.g., during mobilizations against caste quotas). And there seem to be social structures of perception that make it difficult for the privileged to even see some of the social facts that, from an egalitarian point of view, would appear to be problematic. In general, for many middle-class and upper-class citizens of these nations, egalitarian norms seem to have lost the plausibility they had in the aftermath of the anti-colonial protest.




