ENTRY DEADLINE: 5 days before requested relay. You will be notified ASAP after receipt of registration if relay is full. Early registration is encouraged.

ELIGIBILITY: Competitors age **15 and under as of Feb 8** may compete. There is no minimum age limit. NRA membership is not required. Teams will consist of five athletes from the same school or club. No "All Star" teams. Individuals may not participate on more than one team. All competitors are eligible for awards; however, only competitors residing within the state of Georgia are eligible for the GCO BB Gun State Championship award.

COURSE OF FIRE: 4 X 10; 10 shots in each of the 4 positions shot in the order of prone, standing, sitting, kneeling. There will be an initial 2 minute preparation period before the prone position. Preparation period before all other positions will be 1 minute. All positions will be timed at 10 minutes including sighting shots.

ENTRY FEES: \$90.00 per team (5-7 members per team) / \$15.00 for each individual competitor. Make checks payable to Georgia Competitive Shooters. **Late entries** will be assessed an additional \$5.00 per competitor late fee and will be accepted up to range capacity.

SCORING: Orion VIS scoring system will be used.

CHALLENGES: Administrative challenges do not have a fee. Circle the target number associated with each individual target to be examined; bring targets and target score printout to challenge area.

A scoring challenge fee of \$2.00 per individual target is in effect for official score protests.

AWARDS:

These awards will be presented to the following rankings *regardless of the competitor's state of residence*:

1st, 2nd and 3rd place **teams** -team trophy and individual medallions

1st, 2nd and 3rd place *each position* –individual medallions

High individual *total score*– trophy

Georgia residents only -

2020 GCO BB Gun State Champion: High individual *total score*– trophy

NOTE: 2020 GCO BB Gun State Champion is ineligible for High individual award

The top three eligible Georgia teams will be invited to represent the state of Georgia at the 2020 Daisy International BB Gun Championship Match (see <http://www.dnbbgcm.com/>)

RANGE: The Ole Mill Range is an indoor facility with 25 BB firing points. Bleachers are available; team area space is limited.

TARGETS: Orion BB targets and target boxes will be provided. Competitors must bring all other necessary equipment.

REQUIREMENTS: Each **team** must supply an adult coach on the firing line and an adult leader to help with area designated by the match director.

CONCESSIONS: Bottled water, drinks, light snacks are available for purchase at the range.

The Ole Mill Range Complex is located at the corner of Broadway and N. Searcy Ave.

From Atlanta and I-75/I-85 North Metro Areas: Take I-75 South to exit 216 and go south on Highway 155 for approximately 8 miles until you reach the 4-way stop. Turn right onto Jackson Rd. (West) Highway 155 for approximately 5 miles. The Ole Mill Range Complex will be on your left, one mile inside the city limits of Griffin.

From the Spalding County Court House. Travel east on Solomon St for approximately one (1) mile. Cross over the Railroad Tracks at Searcy Ave. Turn North (Left) on Searcy for approximately .3 mile. The entrance to The Ole Mill Range Complex is on the West side (Left) of Searcy Ave, across from UPS.
