<u>Three Position Smallbore, International Air Rifle, and Air Pistol</u> are CMP sanctioned and will be conducted using current CMP rules.

Three Position Air Rifle Match

Equipment classes: PRECISION Air Rifle SPORTER Air Rifle Compressed air is available at the range. **CO2** is **NOT** available at the range.

Course of Fire: All athletes will fire a 60 shot three-position event (3x20)

20-shots in each position of prone (20 minutes), standing (25 minutes), and kneeling (20 minutes).

Targets: MegaLink electronic targets will be used. **Rules:** The Current National Standard Three-Position Air

Rifle Rule Book will apply.

International Standing Match

Equipment classes: PRECISION Air Rifle SPORTER Air Rifle Compressed air is available at the range. **CO2** is **NOT** available at the range.

Course of Fire: All athletes will fire a 60 shot event with a block time of 75 minutes.

Targets: MegaLink electronic targets will be used. **Rules:** Current CMP rules apply.

Air Pistol Match

Course of Fire: All athletes will fire a 60 shot event with a block time of 75 minutes. PPP athletes will fire a 40 shot

event with a block time of 50 minutes.

Targets: MegaLink electronic targets will be used. **Rules:** Current CMP rules apply.

PPP Awards will be mailed at a later date.

There are different categories Progressive Position Pistol (PPP) competitors (based on Current PPP rules):

· Basic Supported (BS) · Standing Supported (SS) · SubJunior International (SJI) · International Standing (IS)

Three Position Smallbore Match

Equipment classes: This is an indoor 50-foot, 3x20 match.

Course of Fire: 3x20; 20 shots in each position of kneeling, prone, standing. There will be a combined 15 minute prep and sighting period prior to firing followed by 105 minute block time.

Ammunition: Standard velocity .22 LR ammunition only.

Targets: MegaLink electronic targets will be used. Rules: Current USA Shooting Rules

4P BB Gun Match (BB)

Course of Fire: This is a non-sanctioned indoor 5 meter, 4X10 match. Spot checks of equipment may be conducted by Match Officials as needed. 2 minute prep period before prone. 1 minute prep period before all other positions. 10 shots in each position of prone (10 minutes), standing (10 minutes), sitting (10 Minutes), and kneeling (10 minutes).

- · Each Athlete must have a coach on the line.
- Unlimited sighting shots may be fired on a single bull <u>VIS</u> paper target before starting record shots in each position.

Targets: <u>VIS</u> paper targets for the Orion scoring system will be used. Match scores will be posted as soon as possible after the last competition shot is fired. A 10-minute challenge period will be observed.

Rules: Current 4X10 NRA BB Gun Rules.

Awards: Overall 1st, 2nd, 3rd medals; additional awards/positional awards will be certificates and a photo opportunity
