III. Ed Johnson, East Tampa Development Manager – Updates

Ed Johnson, East Tampa Development Manager

Presenting two (2) programs for approval at the CRA Board meeting Thursday, October 10th @ 9 a.m. in Council Chambers:

- \$400,000 budgeted for Down Payment Assistance program with a homebuyers education program
 - o \$15,000 maximum per individual
- \$500,000 budgeted for Owner-occupied Rehab program
 - o In conjunction with the existing rehab program run by Housing & Community Development
 - o \$15,000 per applicant (additional)
 - o applications available

Mike Peterson, Neighborhood Enhancement/Code Enforcement Update

- Tree trimming completed along E. 26th Avenue from 26th Street to the railroad tracks going east
- Neighborhood lighting program is funded again for East Tampa
 - o Will start seeing more lights coming in within the next few months
 - o Contact his office with any lights that are out in your neighborhood; include telephone pole number
- Presentation next month on condemned properties and those scheduled for demolition
 - o Hoping to have a map and addresses of properties they will be tearing down or rehabbing
 - o 99% are vacant homes that have been boarded up for years and nothing has been done with them

Det. Roderick Glyder, Environmental Officer - Update

- Monthly report highlights
- Some of these dilapidated homes not dealt with for years/decades; brings down the community
- SWEEP complete in East Tampa; lots of people took advantage of the program
- People buying houses through auction, etc. inherit everything associated with it (code violations, structural issues, permitting and zoning issues, etc.)
- Cameras; illegal dumping

RFP update for the 26 lots:

- Phase II: Eight organizations were shortlisted to present on November 13th.
- Hopefully, we can have a final determination by the end of the year.

Financial Boot Camp: City of Tampa Parks & Recreation Department, presented by Tampa Bay Federal Credit Union; free financial workshop on Saturday, October 26, 11 a.m. - 1:30 p.m. at Cyrus Greene Community Center.

V. Community Input (2 minutes per person and must pertain to agenda items)

Connie Burton: There has been discussion at several City Council meetings about the marijuana dispensary. Was it brought to the CRA's attention prior to being built?

Ed Johnson: No, it's outside of the CRA boundary.

Norene Copeland Miller: The dispensary is 2-3 blocks from the CRA; asked for Chair Goodley's stance on it.

Chair Goodley: We have not discussed it because it is outside of the East Tampa CRA boundary.

MOTION: Norene Copeland Miller moved that the CRA take a stance on the marijuana dispensary that is two blocks from our boundary and is going to affect this community. Seconded by Carol Ransom; 7 voted in favor of taking a stance; 4 voted against; approximately 20 attendees chose not to participate in the vote.

- Chair Goodley will look into if this motion should be carried with 20 or so people abstaining.
- Ed Johnson suggested this issue be addressed through the City Council process or petition.

Michael Farmer: The playground at 30th Street & Osborne has no parking. Chair Goodley stated there is parking at the Clarence Fort Trail; then walk around to the playground.

Betty Bell: We have been asking for a multi-cultural center in this area for years. Councilman Gudes kept his promise that he would see to it that we get a center; we want Al Barnes Park. We had a meeting there last Wednesday and over 25 people showed up; Councilman Gudes talked to us about what we want and need in this community. Thanked the city for giving \$1 million towards the center, the county for \$500,000, and the CAC for \$1 million.

Connie Burton asked for the minutes where we collectively voted to move \$1 million towards that venture. Fair Oaks is in the Strategic Action Plan. They have been promised on every campaign trail; they were at that meeting, as well. Chair Goodley stated the CAC approved it; she does not know the exact meeting date. Call the East Tampa office to request any minutes you would like to have.
