Please read all instructions, terms, and conditions outlined in the enclosed IMMIGRATION ASSESSMENT QUESTIONNAIRE carefully. By completing and submitting this IMMIGRATION ASSESSMENT QUESTIONNAIRE, you agree to comply with the terms and conditions thereof.

You also agree that your payment for assessing your immigration possibilities and preparing your Immigration Assessment Report is **NON-REFUNDABLE** under any circumstances, regardless of the assessment results (whether favourable or unfavourable to you and/or your family members). The assessment of your case is intended to help you and your family members minimize the cost of your immigration procedures and/or possible refusal of your own and/or your family members' immigration applications.

#### **Required Photo Identification Documents**

As required by the Government of Canada and our regulator, the College of Immigration and Citizenship Consultants (CICC (<a href="www.college-ic.ca">www.college-ic.ca</a>)), you are required to present some form of government identification when you retain us to provide our services. #### 2) True Identity Confirmation

As your representative, Iouri Oliinik and/or ICJC are responsible for confirming our Client's true identity with the identification documents of all clients we represent.

#### 3) Possible Conflict of Interest Prevention:

A conflict of interest is a situation that inhibits our ability to:

- Provide clients with our undivided loyalty because of a bias or from past representation from our clients.
- Conflict of interest may also arise during our representation process. 


