The compromise case has been presented before the Tribunal. Petitioners and their Ld. Counsel and Opposite Party No. 3 United India Insurance Company Limited through its Authorized Sigatory Yojana Agrawal appeared.

A reconciliation between the Petitioners and the O.P. No. 3 has been arrived at and the compromise/settlement paper has been presented before the Tribunal. The photocopy of the Aadhar cards of the Petitioners have also been filed with petition. Compromise/settlement paper 22B has been verified in the presence of the both side. The compromise/settlement paper has been read over and explained to the both parties. As per the terms of the said settlement, O.P. No. 3, the United India Insurance Company Limited shall pay ₹4,00,000 (Rupees Four Lakhs) as compensation to the petitioners in full satisfaction, which the petitioners agree to take. The Settlement 22B has been affirmed before the Tribunal by the bonafide parties. Therefore, the Petition is liable to be decided in full satisfaction accordingly-

ORDER

The petition is decided according to the terms of the compromise/settlement paper 22B. Opposite Party No. 3 **United India Insurance Company Limited** is ordered to deposit the compensation amount of **₹4,00,000 (Rupees Four Lakhs)** to the Motor Accident Claim Tribunal's Punjab National Bank Account No. **3671000101192489 IFSC-PUNB0367100** through RTGS/NEFT within **30 days**. Petitioners shall share 50, 25, & 25% respectively and they shall get 50% each in his bank account through electronic mode and 50% each shall be Fix Deposited for 3 years.

The Compromise 22B shall form part of this order. The award be prepared accordingly. The record be consigned as per rules.
