The compromise has been presented before the Tribunal. Petitioner Banmali Sharma and his Ld. Counsel Sri Indra Pal Singh Advocate and Opposite Party No. 3 ICICI Lombard General Insurance Company Limited, through its Ld. Counsel Sri Sunil Shukla appeared.

A reconciliation between the Petitioner and the O.P. No. 3 ICICI General Insurance Company Limited has been arrived at and the compromise/settlement paper has been presented before the Tribunal. The photocopy of the Aadhaar card of the Petitioner has also been filed with the compromise/settlement paper. Compromise/settlement paper has been verified in the presence of the both side. The compromise/settlement paper has been read over and explained to the both parties. As per the terms of the said settlement, O.P. No. 2, the Insurance Company shall pay ₹ 50,000/- (Rupees Fifty Thousand) as compensation to the petitioner in full satisfaction, which the petitioner agree to take. The Settlement 21B has been affirmed before the Tribunal by bonafide parties. Therefore, according compromise/settlement paper 21B, the Petition is liable to be decided in full satisfaction.

ORDER

The petition is decided according to the terms of the compromise/settlement paper 21B. Opposite Party No. 1 ICICI General Insurance Company Limited is ordered to deposit the compensation amount of ₹ 50,000/- (Rupees Fifty Thousand) to the Motor Accident Claim Tribunal's Syndicate Bank Account No. 92352010008560 IFSC-SYNB0009235 through RTGS/NEFT within 30 days. On depositing the said compensation, the whole amount shall be transferred into the petitioners bank account through electronic mode on the satisfaction of Tribunal.

The Compromise 21B shall form part of this order. The award be prepared accordingly. The record be consigned as per rules.
