Misc. Case No. 02 of 2020 (MACP No. 242 of 2017) Smt. Rani Rajpoot & Ors. vs. Sri Vaidyanath Ayurved Pvt. Ltd. & Ors. 17.06.2021

The case presented before the Tribunal. Applicants with their counsel appeared through Video Conferencing.

Heard and perused the record of MACP No. 242 of 2017 which transpires that on the basis of merit, a compensation of ₹8,76,400 with 7% annual interest from the date of institution was awarded by the MACT Jhansi/Spl. Judge (DAA) in favor of the applicants/petitioners on date 07.09.2019.

As per office report awarded amount and interest thereon ₹10,31,847 have been deposited by the United India Insurance Company through cheque No. 009428 in the Tribunal's account of Punjab National Bank. This Misc. case has been instituted by the applicants to release the deposited amount in terms of the award and Hon'ble High Court of Allahabad order in 89 with 90 of 2020 by which appeals of United India Insurance Co. Ltd. on the ground of permit have been dismissed.

In support of execution cum release application 3B, the affidavit 4C2 is available on the record. Applicants have also filed their Adhaar Card and bank account details.

In my view applicants are entitled to get deposited amount in their bank accounts in terms of the award and Hon'ble High Court order. Hence-
