

Motor Accident Claim Tribunal Jhansi

The case presented before the Tribunal in virtual Court. Applicants with their counsel appeared through VC.

Heard and perused the record of MACP No. 485 of 2018 which transpires that on the basis of compromise, a compensation of ₹8,25,000 was awarded by MACT Jhansi in favor of the applicants/petitioners on date 09.03.2021. Awarded amount has been distributed between claimants in the shares of 35, 25, 25, 05, & 10%. As per office report awarded amount has been deposited Tribunals PNB Account through UTR No. N)86211453477531 on 27.03.2021. As per award 75% of share of Claimant No.1 has to be invested in annuity for 5 years, 75% of shares of Claimants No.4 &5 have to be invested in annuity for 3 years and 100% of share of Claimants No.2 & 3 have to be invested in annuity for 10 years. Claimants No. 1, 4 & 5 are entitled to get 25% of their share in their bank accounts through RTGS.

In support of release application 3B, the affidavit 4C2 is available on the record, according to which no appeal has been preferred against award nor any stay has been granted.

In my view applicants are entitled to get deposited amount in terms of the award. Hence-
