Misc. Case No. 14 of 2020 Harpal Singh and ors. Vs. Bhagwan Singh and ors. Related MACP No. 268 of 2007

The case is presented before the Tribunal in Virtual Court. Due to the increasing prevalence of COVID-19, Ld. Counsel for applicants is heard through video conferencing. The applicants Kashi Devi, Gauravi and Gaurav are also present on video conference.

Perused the summoned record of the MACP No. 268 of 2007 which makes it clear that on the basis of merit, a compensation of Rs. 11, 16, 219 was awarded by MACT/Additional District (Court No. 6) Jhansi in favour of applicants on date 03/09/2019 which was paid by the United India Insurance Company Limited. As per Syndicate Bank Jhokan Bagh Jhansi report, the amount Rs. 18,70,774 was deposited in the Tribunal's account of Syndicate Bank in the matter of MACP No. 268 of 2007. This Misc. case has been instituted by the applicants in order to get the deposited amount and interest thereon in their accounts in terms of the award. The affidavit of applicant Kashi Devi is available on the record of Misc. case as per which no apeal is pending in any Court. As per award, applicant Kashi Devi has to get Rs. 1,00,000 in her account and Rs. 4,00,000 have to be fixed in any nationalised bank for 3 years in her name. Applicant Gauravi has to get Rs. 50,000 in her account and Rs. 2,50,000 have to be fixed in any nationalised bank for 3 years in her name. Applicant Gaurav has to get Rs. 50,000 in his account and Rs. 2,50,000 has to be fixed in any nationalised bank for 3 years in his name. Applicant Laxmi Devi has to get Rs. 56,219 in his account and Rs. 60,000 have to be fixed in any nationalised bank for 3 years in his name. Another application supported by the affidevit to this effect has also been pressed that the claimant No. 1/4 Laxmi Devi has been died and remaining claimants are legal representatives of the deceased Laxmi Devi as they are daughter-in-law, grand daughter and grand son respectively, hence they are entitled to get share of deceased Laxmi Devi equally. Applicants stated their bank account nos. as following-

Photocopies of abovementioned a/c nos. have been placed on the record.

In the light of above and having considered case law <u>Smt. Rukhsana and others vs. Nazrunnisa and another, MANU/SC/2586/2000</u>, I am of the view that the ammount deposited should be released in favor of the remaining applicants. Hence,

ORDER

Syndicate Bank Jhokan Bagh Jhansi is ordered to disburse deposited ammount as following—
