Smt. Sanju and ors. Vs. Ambey Supplier Pvt. Ltd. and ors. Related MACP No. 77 of 2018

The case was presented before the Tribunal in Virtual Court. Applicants with her counsel were appeared in the Virtual Court.

Perused the summoned record of the MACP No. 77 of 2018 which makes it clear that on the basis of merit, a compensation of ₹ 11,25,290 with 7.5% simple interest was awarded by MACT Jhansi in favor of the applicants on date 13.05.2020 against which ₹ **12,70,128** have been paid by The Magma HDI General Insurance Company Limited. As per office report aforesaid amount is deposited in Tribunal's account of Syndicate Bank. This Misc. case has been instituted by the applicants to release the deposited amount and interest thereon in terms of the award in their bank accounts as following-
