Misc. Case No. 160 of 2021 (MACP No. 317 of 2015) Smt. Vineeta & Ors. vs. Anand Singh & Ors. 23.06.2021

The case presented before the Tribunal. Applicants with their counsel & Counsel of National Insurance Co. Ltd. appeared virtually.

Heard and perused the record which transpires that initially ₹50,10,447 with 7.5% interest were awarded to the claimants in MACP No. 317 of 2015 on date 15.09.2020 by the MACT Jhansi and thereafter in Appeal by IC before Honb'le High Court of Allahabad following order has been passed-

'Out of the amount so deposited, the respondent nos. 1, 4, 5 and 6 shall be entitled to withdraw half of the awarded amount without furnishing any security. The remaining half of their amount shall be deposited in a nationalised bank fetching higher rate of interest for a period of three years, awaiting the result of this appeal. For minors, respondent nos. 2 and 3, the awarded amount will be deposited in a nationalised bank fetching higher rate of interest for a period of three years, awaiting the result of this appeal. Order Date: 13.1.2021'

As per office report ₹68,57,259 have been transferred by The New India Insurance Co. Ltd. electronically through UTR No. AXISP00181429014 in Tribunal's Punjab National Bank Account.

Through Misc. Case No. 160 of 2021 applicants have prayed for release of amount.

In support of release application 3B, the affidavit 4C2 is available on the record. Photocopies of Adhaar Cards and Bank details have also been filed by the applicants.

In my view applicants are entitled to get deposited amount in their bank accounts in terms of the award. Hence-
