**Smt. Hareshbai & ors. Vs. Mukesh & ors. Related MACP No. 163 of 2017

The case presented before the Tribunal. Applicants with their counsel appeared on previous date.

Heard and perused the record which makes it clear that on the basis of compromise, a compensation of **₹7,00,000** was awarded by MACT Jhansi in favor of the applicants on date 12.12.2020. As per office report awarded amount has been paid by the Insurance Company through **UTR No. HSBCN20364934852** which is deposited in Tribunal's account of Punjab National Bank. This Misc. case has been instituted by the applicants to release the deposited amount and interest thereon in terms of the award in their bank accounts.

In support of release application, the affidavit of Hareshbai and photocopy of Aadhar Cards of Applicants are available on the record.

In my view applicants are entitled to get deposited amount in terms of the award. Hence-
