Heard and perused the record of MACP No. 226 of 2019 which transpires that on the basis of compromise, a compensation of ₹ 8,00,000 was awarded by MACT Jhansi in favor of the applicant on date 12.12.2020. As per office report awarded amount has been transferred by the Insurance Company in to the Tribunal's account of Syndicate Bank through reference No. N366201356881129 on 31.12.2020. This Misc. case has been instituted by the applicants to release the deposited amount and interest thereon in terms of the award in their bank accounts.

In support of release application the affidavit 4C2 and photocopies of Aadhar Cards and bank passbooks are available on the record.

In my view applicants are entitled to get deposited amount in their bank accounts in terms of the award. Hence-
