Misc. Case No. 57 of 2020 Smt. Urmila Devi Vs. Akhilesh and ors. Related MACP No. 369 of 2017

The case is presented before the Tribunal in Virtual Court. Due to the increasing prevalence of COVID-19, Ld. Counsel for applicants is heard through video conferencing. The petitioners/applicants Smt. Urmila Devi and Prahlad is also present on video conference.

Perused the certified copy of the Petition and Judgement of the MACP No. 369 of 2017 which makes it clear that on the merits of the case, a compensation of Rs. 3,41,800 with 7% simple interest from the date of institution of petition till actual recovery was awarded by the MACT/ Special Judge (DAA) Jhansi in favour of the applicant on date 25/11/2019 which was paid by the Chola Mandalam M S General Insurance Company Limited on 31.01.2020. As per office record at S.N. 34A the amount Rs. 3,87,056 was deposited in the Tribunal's account of Punjab National Bank. This Misc. case has been instituted by the petitioners/applicants to get the deposited amount and interest thereon in her account in terms of the award. In support of her release application the affidavit of applicant Urmila is available on the record according to which neither stay order by the Hon'ble High Court is prevailing nor the matter is subjudice. As per award, out of the compensation amount petitioner/applicant Urmila Devi has to get Rs. 2,41,800 plus whole interest of which 30% shall be transferred to her bank account and 70% shall be fixed for one year in any nationalized bank in her name and petitioner/applicant Prahlad has to get Rs. 1,00,000 of which 30% shall be transferred to his bank account and 70% shall be fixed for one year in any nationalized bank in his name. Applicant stated his bank account no. as following-

Prahlad 37074568611 — State Bank of India Moth, Jhansi

Photocopy of abovementioned a/c nos. have been placed on the record.

In the light of above, I am of the view that the amount deposited should be released in favor of the petitioners/applicants. Hence-
