

Motor Accident Claim Tribunal, Jhansi

Misc. Case No. 67 of 2020 Pooja and ors. Vs. Amrit Lal and ors. related MACP No. 403 of 2017

24/07/2020

The case is presented before the Tribunal in Virtual Court. Due to the increasing prevalence of COVID-19, Ld. Counsel for applicants is heard through video conferencing. The applicants Pooja, Aryan, Shiv Charan and Shanti are also present on video conference.

Perused the summoned record of the MACP No. 403 of 2017 which makes it clear that on the basis of merit, a compensation of Rs. 11,92,660 was awarded by MACT Jhansi in favour of applicants on date 05/06/2020 which was paid by the United India Insurance Company Limited. As per office record, the amount Rs. **14,19,347** have been deposited in the Tribunal's Punjab National Bank account. This Misc. case has been instituted by the applicants in order to get the awarded amount and interest thereon in their accounts in terms of the award. The affidavit of applicant Pooja in support of release application is available on the record of misc. case as per which no appeal is pending in the Hon'ble High Court. As per award, Petitioner No. 3 and 4 Mrs. Shanti and Mr. Shiv Charan have to share 20% each, Petitioner No. 1 Mrs. Pooja and Petitioner No. 2 Master Aryan (Minor) have to share 30 % each. 80% of the share of the Petitioner Nos. 1, 3 and 4 have to be deposited in fixed accounts for 5, 3 and 3 years respectively. Petitioner Nos. 1, 3 and 4 have to get monthly or annually interest of the fixed deposits. The whole share of Petitioner No. 2 Master Aryan (Minor) have to be invested in fixed deposit up to his majority. Applicants submitted their bank account nos. as following-
