

Motor Accident Claim Tribunal, Jhansi

The case is presented before the Tribunal in Virtual Court. Due to the increasing prevalence of COVID-19, Ld. Counsel for applicants is heard through video conferencing. The applicants Taaj Bano, Mahra, Sumera and Lallu khan are also present on video conference.

Perused the summoned record of the MACP No. 138 of 2019 which makes it clear that on the basis of merit, a compensation of Rs. 11,30,290 was awarded by MACT Jhansi in favour of applicants on date 06/03/2020 which was paid by the New India Insurance Company Limited. As per office report, the amount Rs. **12,01,898** was deposited in the Tribunal’s account of Syndicate Bank. This Misc. case has been instituted by the applicants in order to get the awarded amount and interest thereon in their accounts in terms of the award. The affidavit of applicant Taj Bano in support of release application is available on the record of misc. case as per which no appeal is pending in the Hon’ble High Court. As per award, petitioner no. 2 and 3 have to get 30% – 30% share which shall be fixed deposited in any highest interest carrying scheme of any nationalized bank up to their majority in their names. Petitioners no. 1 and 4 have to get Rs. 25% and 15% respectively of which 80% amount have to be fixed deposited in any highest interest carrying scheme of any nationalized bank for 3 and 5 years respectively in their names. Remaining amount have to be transmitted through RTGS/NEFT in their accounts. Applicants submitted their bank account nos. as following–
