The case was presented before the Tribunal in Virtual Court. Applicants with her counsel were appeared in the Virtual Court through VC.

Perused the summoned record of the MACP No. 255 of 2017 which makes it clear that on the basis of merit, a compensation of ₹ 6,83,600 with 7% simple interest was awarded by MACT/ADJ (Court No. 6) Jhansi in favor of the applicants No. 2, 3, and 4 on date 09.10.2019 against which ₹ 7,67,206 have been paid by The National Insurance Company Limited. As per office report aforesaid amount is deposited in Tribunal’s account of Syndicate Bank. This Misc. case has been instituted by the applicants to release the deposited amount and interest thereon in terms of the award. As per high school certificate Km. Deepika is major now.
