Misc. No. 8 of 2021 Hariram Raikwar and ors. Vs. Kuldeep Singh and ors. Related MACP No. 132 of 2016

The case presented before the Tribunal.

Having heard perused the record of the MACP No. 132 of 2016 which makes it clear that on the basis of merit, a compensation of Rs. 12,08,100 was awarded by MACT Jhansi in favour of applicants on date $17/07/2021^{\circ}$. United India^{National}Insurance Company Limited have submitted order of Hon'High Court in FAFO Defective No. 497 of 2020 which is as following-

"On appellant depositing the entire awarded amount before the Tribunal, the execution of the order impugned shall remain stayed. Out of the entire deposited amount, 50% shall be allowed to be withdrawn by claimants and 50% shall be invested in a Fixed Deposit Account-carrying maximum interest for minimum period of three years and the interest on it be paid to claimants."

As per MACT Jhansi office report, the amount of Rs. 14, 22, 403 have been paid by the United India^{National}Insurance Company Limited through electronic transfer having UTR No. KKBK203395902435^{&KKBK203436608486} which are deposited in the Tribunal's account of Syndicate Bank. This Misc. case has been instituted by the applicants in order to get the deposited amount and interest thereon in their accounts in terms of the award and order in FAFO (D) No. 497 of 2020. The affidavit of applicant Hari Ram Raikwar in support of his release application 3B is available on the record. Km. Swati Raikwar appears to be major now. Under these facts and circumustances, I am of the view that the ammount deposited should be released in favor of the remaining applicants. Hence,

<u>ORDER</u>

Syndicate Bank Jhokan Bagh Jhansi is ordered to disburse deposited ammount as following-
