

Motor Accident Claim Tribunal, Jhansi

Misc. Case No. 82 of 2020 Rajkumari & ors. Vs. Suraj Pal aka Suryapal and ors. related MACP No. 345 of 2017

The case is presented before the Tribunal in Virtual Court. Due to the increasing prevalence of COVID–19, Ld. Counsel for applicants is heard through video conferencing. The applicants also had appeared on video conference.

Perused the summoned record of the MACP No. 345 of 2017 which makes it clear that on the basis of merit, a compensation of Rs. 7,50,413 with 7.5 % simple interest was awarded by this Tribunal in favor of applicant on date 22.02.2020 which was paid by the United India Insurance Company Limited. As per office record of Cheque Register at S.N. 91, the amount **Rs. 8,99,747** have been deposited in the Tribunal’s account of Punjab National Bank. This Misc. case has been instituted by the applicant in order to get the awarded amount and interest thereon in their accounts in terms of the award. The affidavit of applicant Rajkumari in support of release application is available on the record of Misc. case as per which neither appeal has been presented before the Hon’ble High Court nor any stay has been passed.p

Applicants have right to get their amount back.

Applicants have submitted photocopies of their bank account nos. and Aadhar Cards

In the light of above, I am of the view that compensation amount should be disbursed according to the Judgment of this Tribunal.

ORDER

Punjab National Bank Jhokan Bagh Jhansi is ordered to disburse deposited amount of **MACP No. 345 of 2017 Rajkumari & ors. Vs. Suraj Pal aka Suryapal and ors.** according to following sheet–
