

Misc. Case No. 96 of 2020 Smt. Ramshri and ors. Vs. M/s Murli Granites and ors. related MACP No. 351 of 2019

The case is presented before the Tribunal in Virtual Court. The applicants Ramshri, Mithilesh, Sumit, Dilip and Smt. Saroj are present on video conference. Due to the increasing prevalence of COVID-19, I have heard Learned Counsel of the applicants through video conferencing.

Perused the summoned record of the MACP No. 351 of 2017 which makes it clear that on the basis of merit, a compensation of Rs. 10,02,600 with 7% simple interest was awarded by MACT/ADJ Jhansi (Court No. 6) in favor of applicants on date 24.12.2019. As per office report, ₹ 11,65,346 has been paid by the IFFCO Tokio General Insurance Company Limited in compliance of the award and the amount is deposited in the Tribunal's Syndicate Bank Account. This case has been instituted by the applicants to release the amount and interest thereon in their bank accounts in terms of the award. The affidavit of applicant Ramshri in support of release application is available on the record as per which no appeal in her knowledge has been preferred before Honb'le High Court by the Insurance Company.

In the light of the award, I am of the view that deposited amount should be disbursed accordingly.

ORDER

Syndicate Bank Jhokan Bagh Jhansi is ordered to disburse deposited amount of **MACP No. 351 of 2019 Smt. Ramshri and ors. Vs. M/s Murli Granites and ors.** according to the following sheet-
