Motor Accident Claim Tribunal Jhansi

Misc. No. 117 of 2021 (MACP No. 191 of 2018) Smt. Shabnam Bano and Ors. vs. Shakir & Ors. 28.06.2021

The case presented before the Tribunal. Applicants with their counsel appeared virtually on previous date. Through **Application 3B** applicants have prayed for release of amount.

Heard and perused the record which transpires that on the basis of merit following award was passed by the **MACT Jhansi** in **MACP No.** 191 of 2018 on date 19.02.2021-

The Claim Petition is partially allowed for compensation ₹17,18,360 (Rupees Seventeen Lakh Eighteen Thousand Three Hundred and Sixty) with 7.5% simple annual interest from the date of institution of the petition till the date of deposition/recovery. Opposite Party No. 2 United India Insurance Company Limited is ordered to deposit the amount of compensation with interest in tribunal's Punjab National Bank Account Number 3671000101192489 IFSC- PUNB0367100 through RTGS/ NEFT within 45 days from the date of the order and submit UTR/Referencce/Transaction number in the office of this Tribunal. Petitioners No. 1, 2, 3, 4, and 5 shall share 35, 20, 20, 20 and 5 percent of total compensation. Out of total compensation 75% of Petitioner No. 1 shall be invested in annuity in any Nationalized Bank for 5 years, 75% of Petitioner No. 5 shall be invested in annuity in any Nationalized Bank for 3 years and 100% of Petitioners No. 2, 3, 4 shall be invested in annuity in any Nationalized Bank for 10 years through Natural Guardian mother Petitioner No.1. Petitioners No. 1 and 5 shall get rest 25% amount in their Bank Accounts through RTGS/NEFT.

As per office report ₹20,54,570 have been deposited by the United India Insurance Company Limited in Tribunal's Punjab National Bank Account through UTR No. 0075671256

In support of release application 3B, the affidavit 4C2 is available on the record. As per affidavit neither any is in operation nor appeal has been preferred against the award. Photocopies of Adhaar Cards and Bank details have also been furnished by the applicants.

Considering all the facts and circumstances, I am of the view that applicants are entitled to get the amount as per award. It is added that natural guardian Smt. Shabnam Bano can receive the annuity proceeds of minors till they attain majority so as to take care of them. Alternatively, shares of minors may be Fix Deposited till their majority. Hence-
